

THE WEEK'S HIGHLIGHTS:

- ✓ The M2 money stock rose at a 0.5 percent annual rate from the four-week period ending September 17, 1990, to the latest four-week period.
- ✓ The federal funds rate averaged 6.88 percent for the week ending January 23, down sharply from the 8.20 percent average for last September.
- ✓ The U.S. federal budget deficit was \$7.4 billion in December, down substantially from \$48.1 billion in November and from \$14.8 billion a year earlier. The total deficit from October through December was \$86.9 billion, compared with \$70.6 billion for the same period a year earlier.
- ✓ The seasonally adjusted merchandise trade deficit narrowed to \$9.7 billion in November from a revised \$10.99 billion in October. For the first 11 months of 1990, the adjusted trade deficit totaled \$94.95 billion, compared with \$102.60 billion for the same period in 1989.













AVERAGES OF DAILY RATES










BORROWINGS FROM FEDERAL RESERVE BANKS






