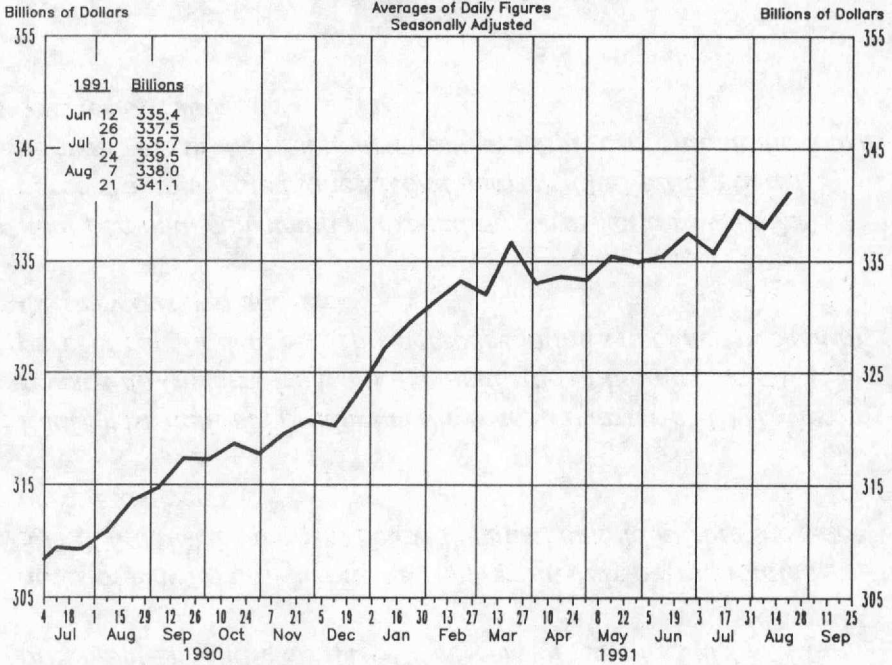

THE WEEK'S HIGHLIGHTS:

- ✓ *Real disposable personal income fell at a 1.3 percent annual rate in July, after rising at a 5.6 percent rate during the previous two months.*
- ✓ *Orders for durable goods in July increased 10.7 percent to \$129.9 billion, after falling a revised 1 percent in June to \$117.3 billion.*
- ✓ *Sales of new homes during the January-to-July period totaled 305,000 units, 13 percent below the number sold during the same period last year.*
- ✓ *Real gross national product in the second quarter of 1991 was revised downward, from a 0.4 annual rate of increase to a 0.1 percent rate of decline. This decrease follows declines in each of the previous two quarters.*
- ✓ *Real personal consumption expenditures rose at a revised 2.8 percent annual rate in the second quarter, after falling at a 1.5 percent rate in the first quarter and a 3.4 percent rate in the fourth quarter of 1990.*

The adjusted monetary base is the sum of reserve accounts of financial institutions at Federal Reserve banks, currency in circulation (currency held by the public and in the vaults of all depository institutions) and an adjustment for reserve requirement ratio changes. The major source of the adjusted monetary base is Federal Reserve credit. Data are computed by this bank. A detailed description of the adjusted monetary base is available from this bank.

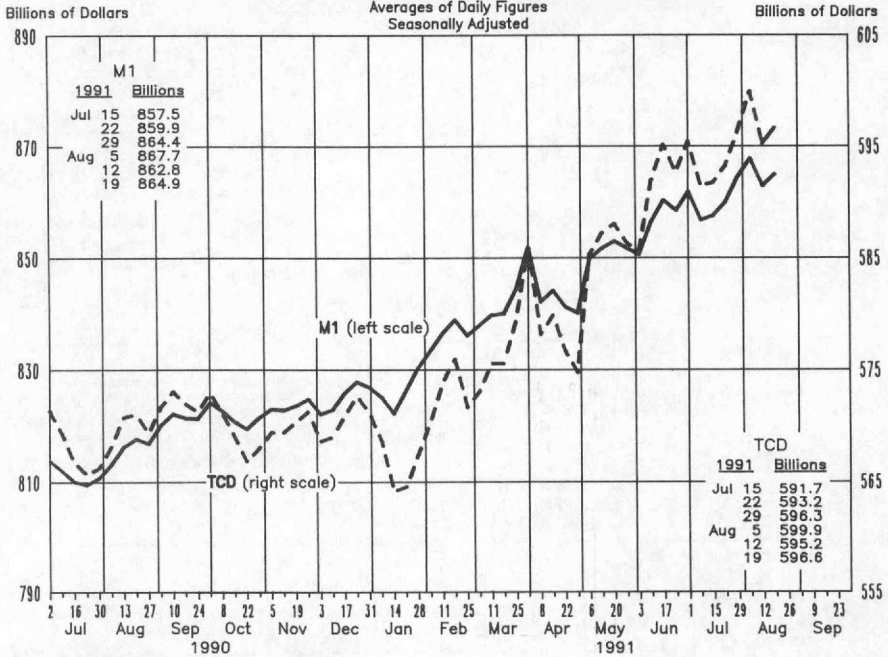

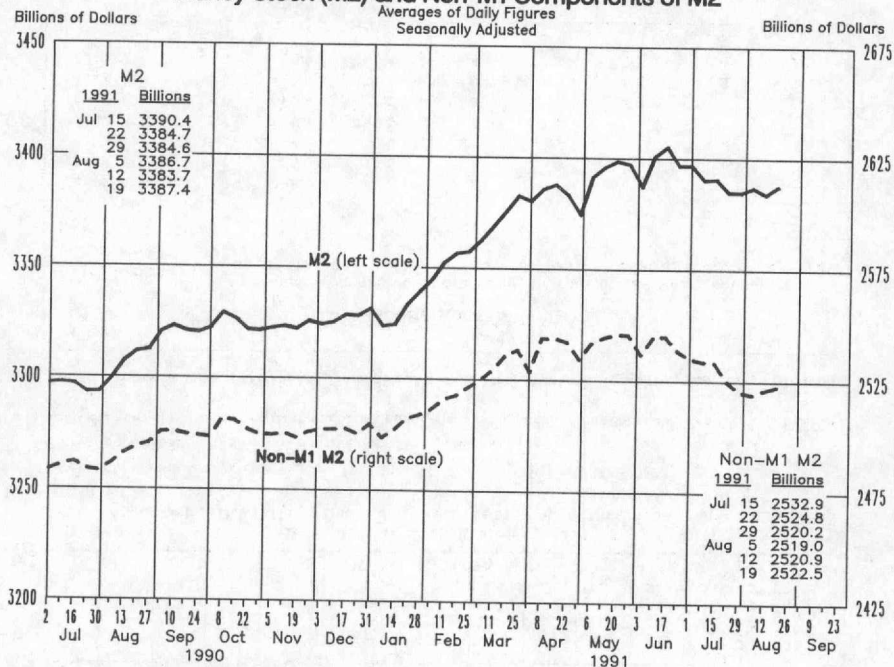

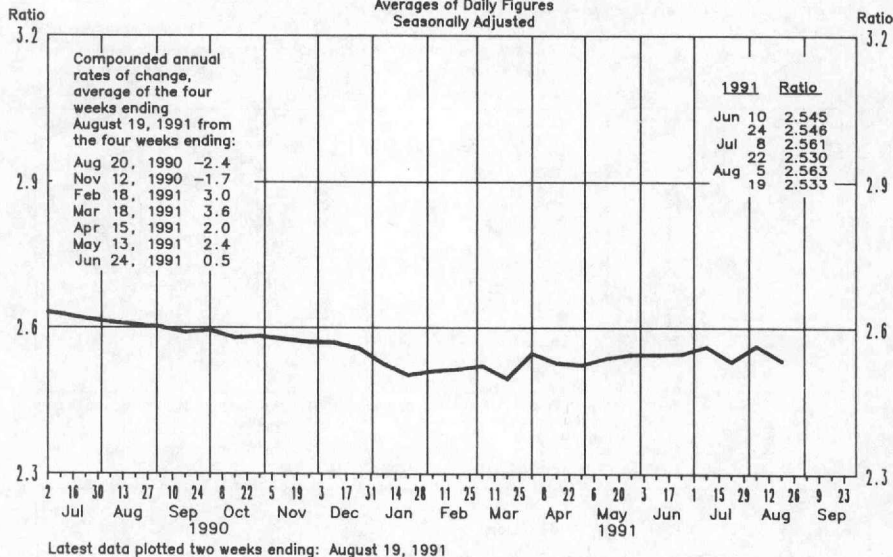

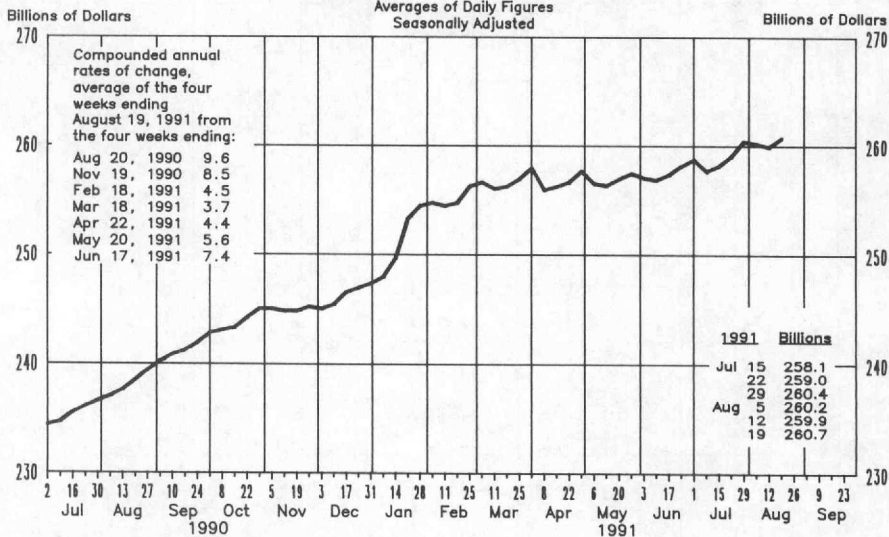
Money Multiplier^{1/}

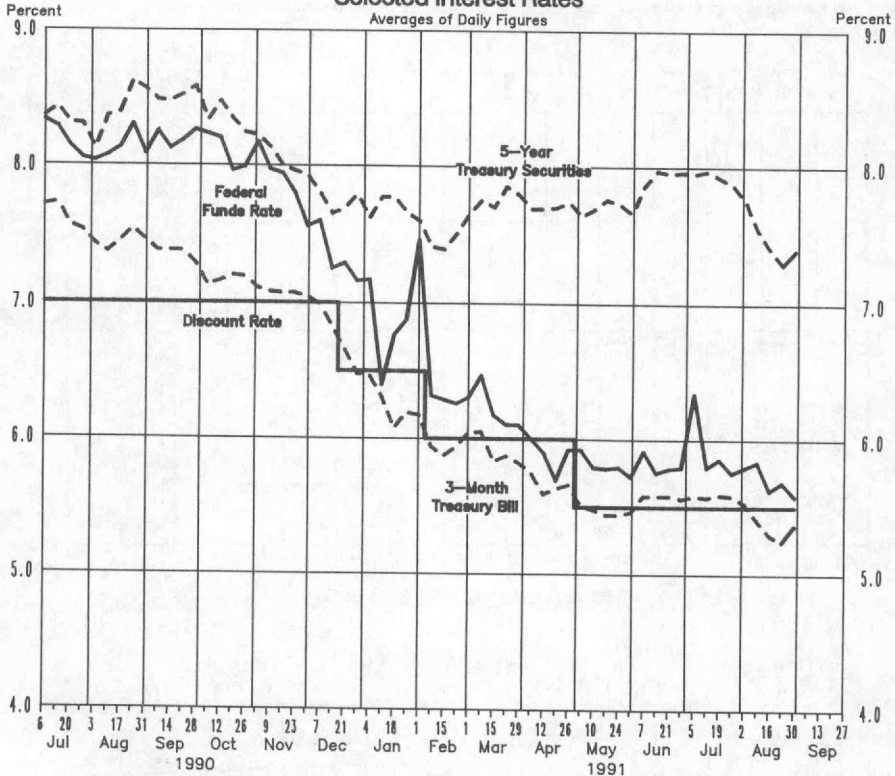

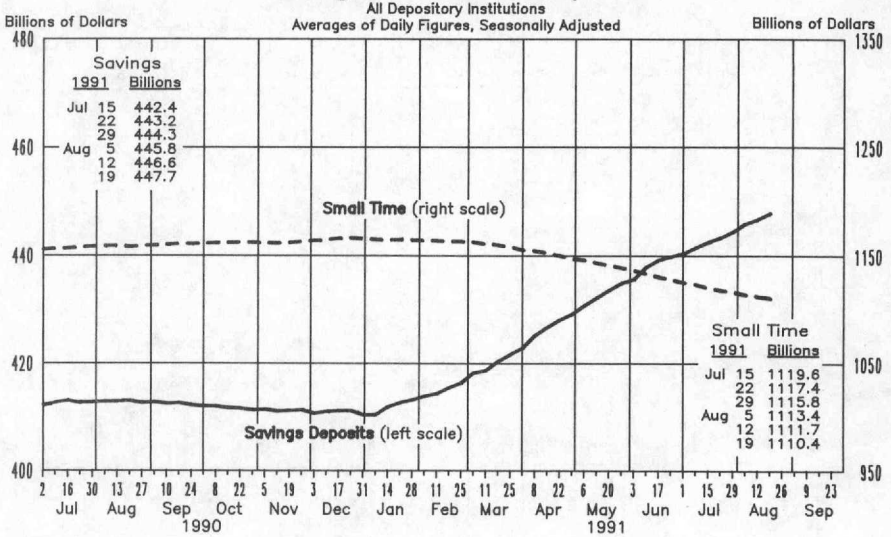

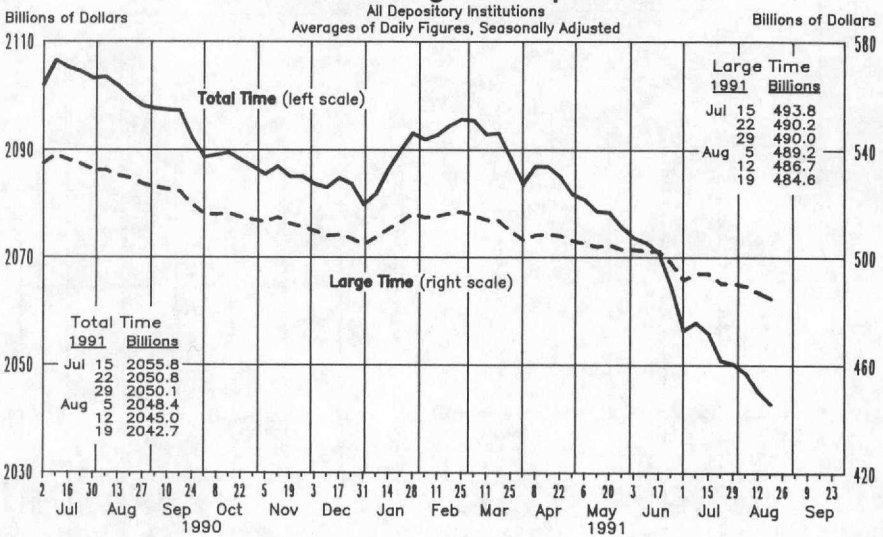

Total and Large Time Deposits ^{1/}



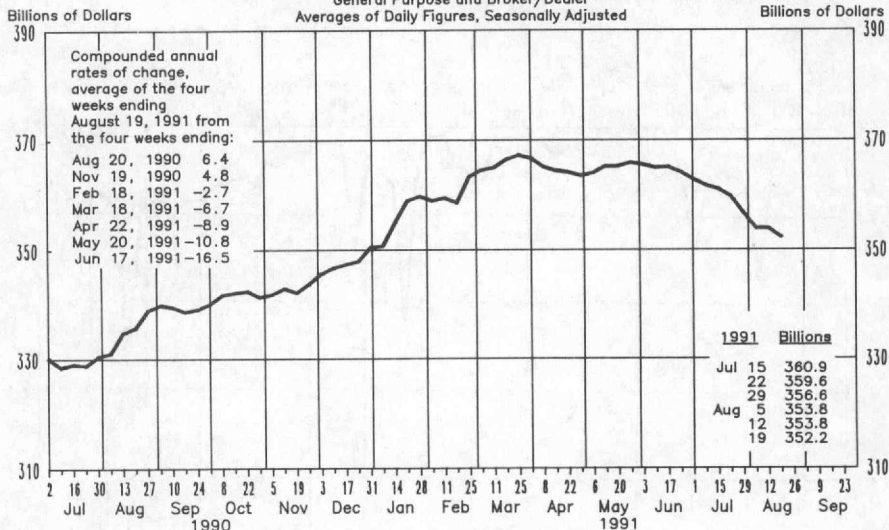

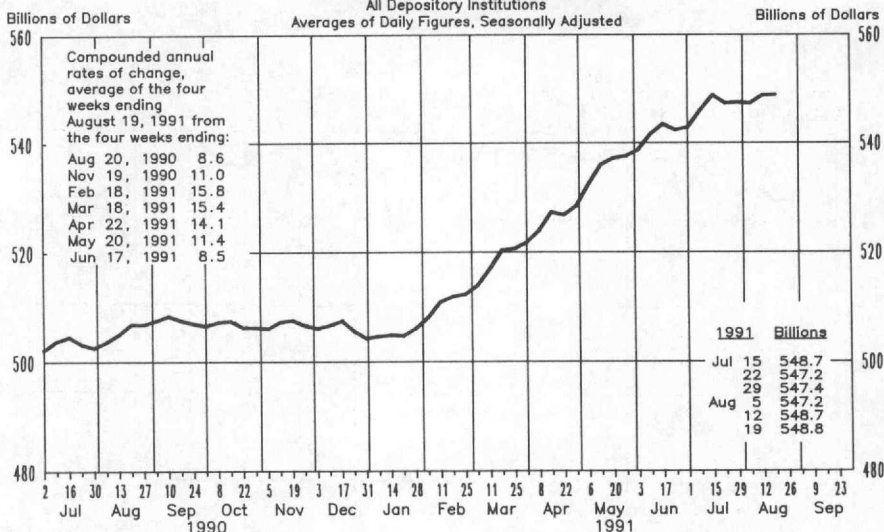
Money Market Funds

Averages of Daily Figures, Seasonally Adjusted

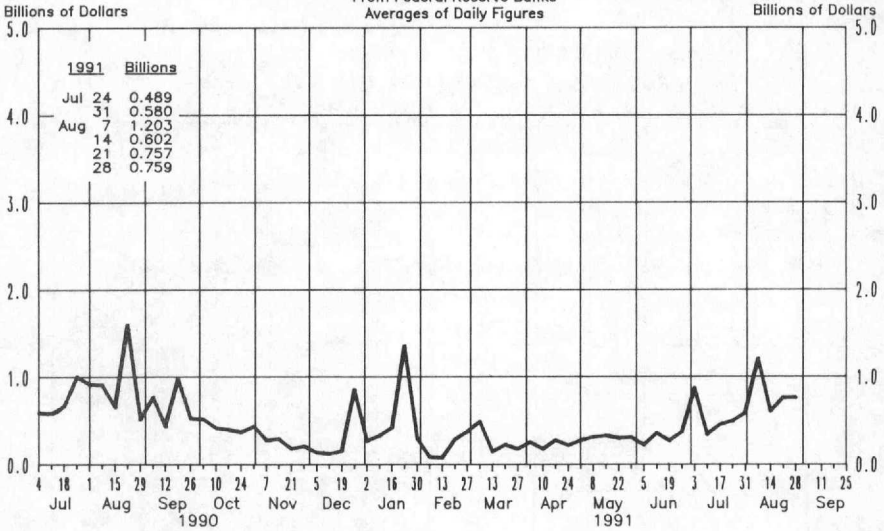

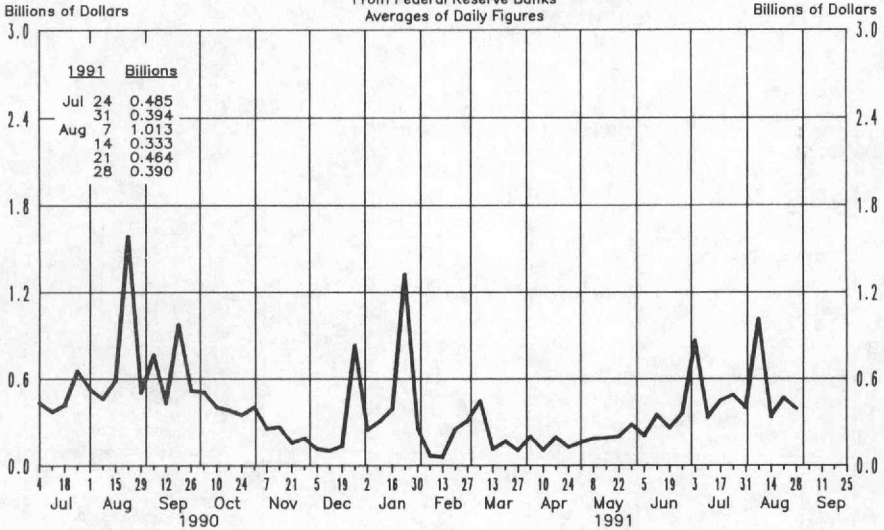
Total Borrowings

Adjustment + Seasonal Borrowings

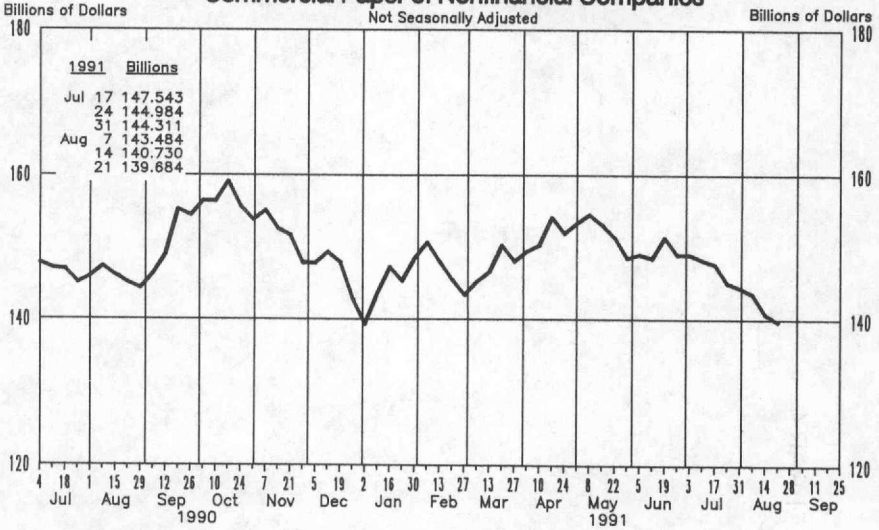

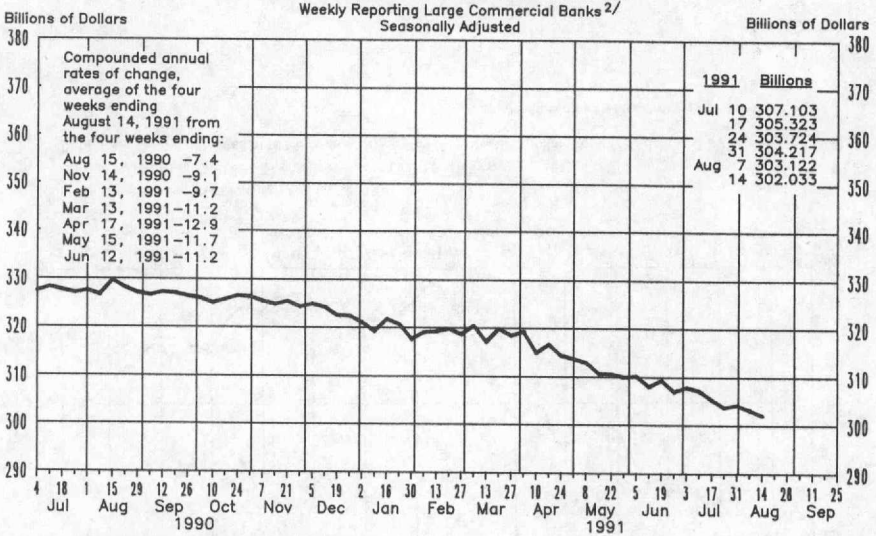

Commercial and Industrial Loans^{1/}

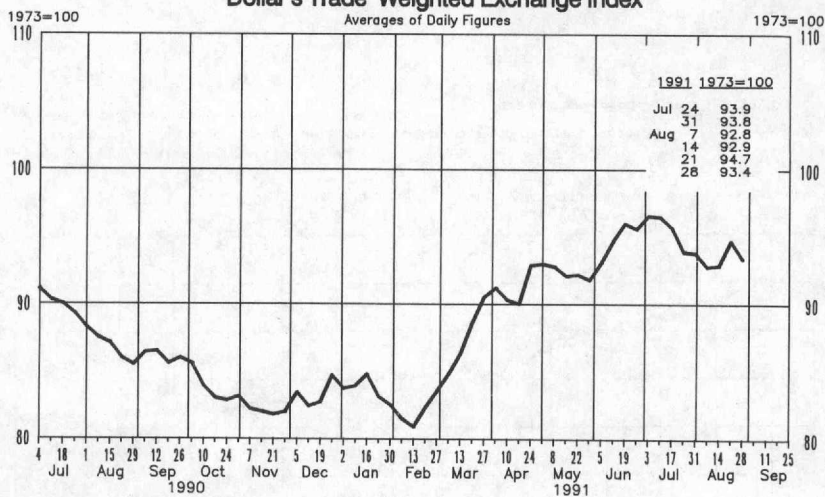
