## THE WEEK'S HIGHLIGHTS:

- *Real gross domestic product fell at a 0.4 percent annual rate in the third quarter, according to advance estimates. This was the first quarterly decline since the first quarter of 1993. Business investment fell at an 11.9 percent rate—the third consecutive quarterly decline—shaving 1.53 percentage points from GDP growth. Consumer spending rose at a 1.2 percent annual rate, about half its rate in the second quarter. Meanwhile, the price index for personal consumption expenditures fell at a 0.4 percent annual rate in the third quarter.*
- *In September, consumer spending fell 1.8 percent in current prices, the largest one-month decline since January 1987, following a 0.3 percent increase in August. Spending on durable goods declined 3.2 percent. Personal income, however, was unchanged from August.*
- *The Conference Board's index of consumer confidence declined from 97.0 in September to 85.5 in October, its lowest level since February 1994.*
- *The Purchasing Managers Index of the National Association of Purchasing Management (NAPM) declined from 47.0 in September to 39.8 in October, the 15th consecutive monthly reading below 50. Readings below 50 indicate contraction in manufacturing activity.*
- *The number of workers filing first-time claims for unemployment benefits fell by 10,000 to 499,000 in the week ending October 27.*

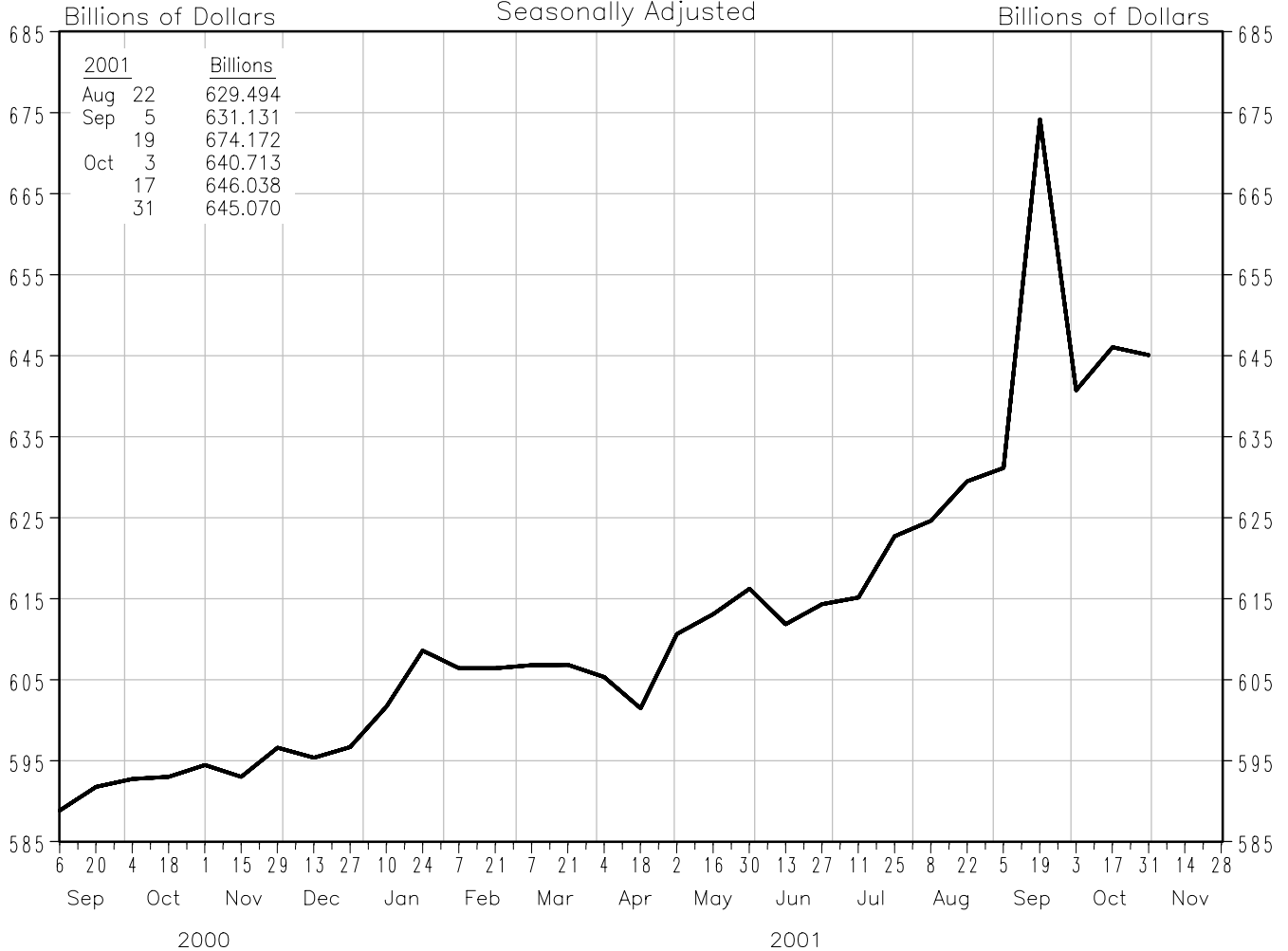

Seasonally Adjusted



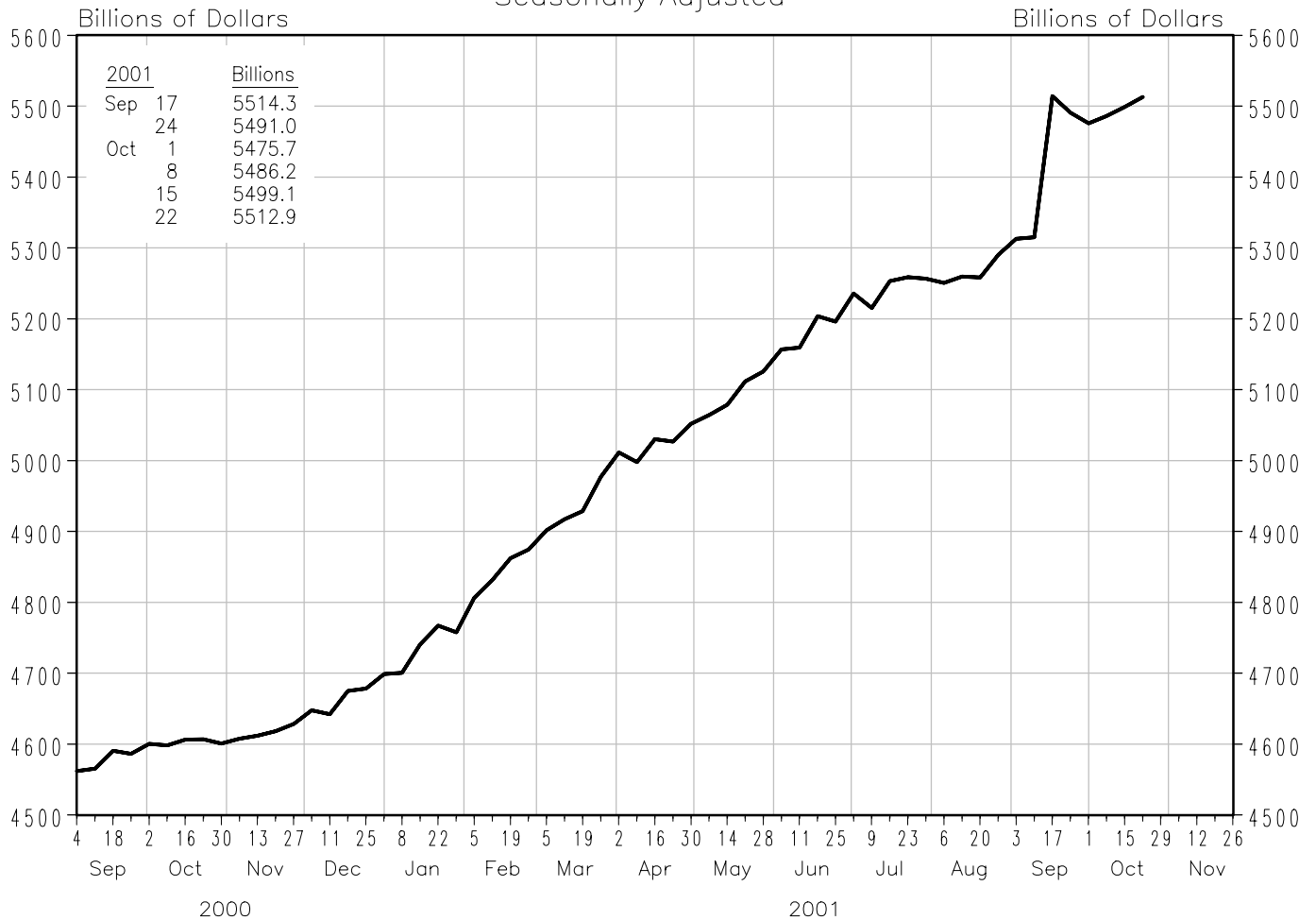
The adjusted monetary base is the sum of Federal Reserve deposits and vault cash held by domestic depository institutions, currency held by the public, and an adjustment for the effect of changes in reserve requirement ratios. The monetary base series includes Federal Reserve deposits used to satisfy clearing balance contracts. Data are computed by this bank. A detailed description of the adjusted monetary base is available from this bank. Recent data are preliminary.

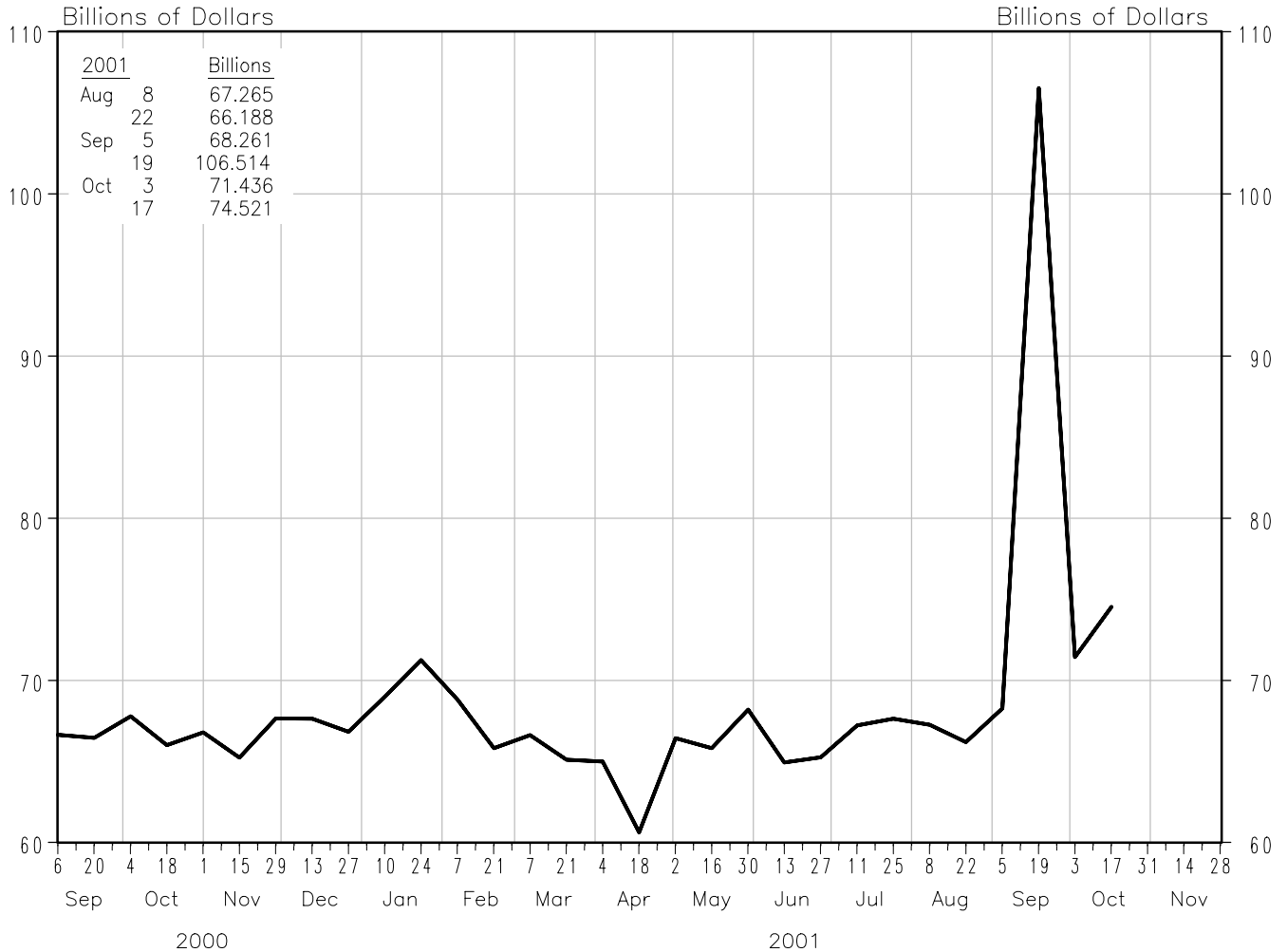

Seasonally Adjusted



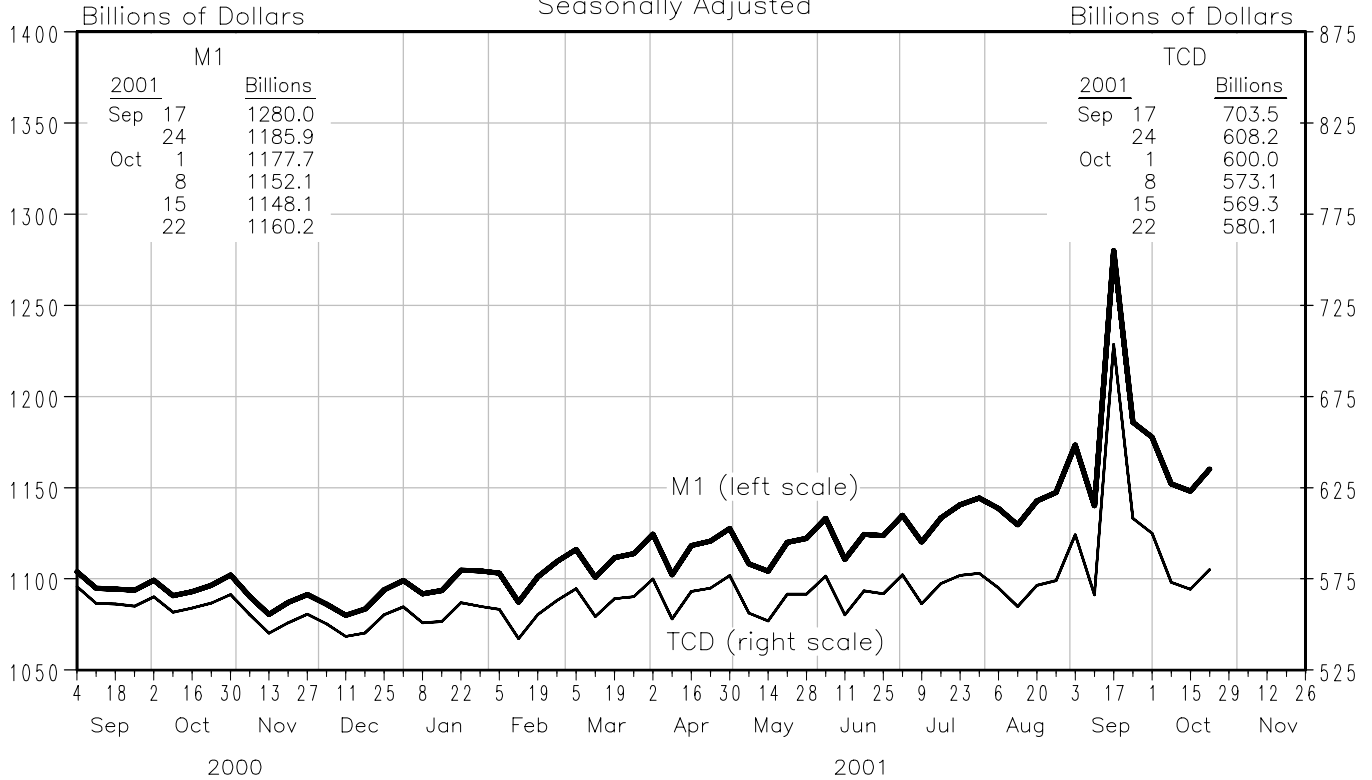
Adjusted reserves is the difference between the adjusted monetary base and the currency component of M1.

# Money Stock(M1) and Total Checkable Deposits

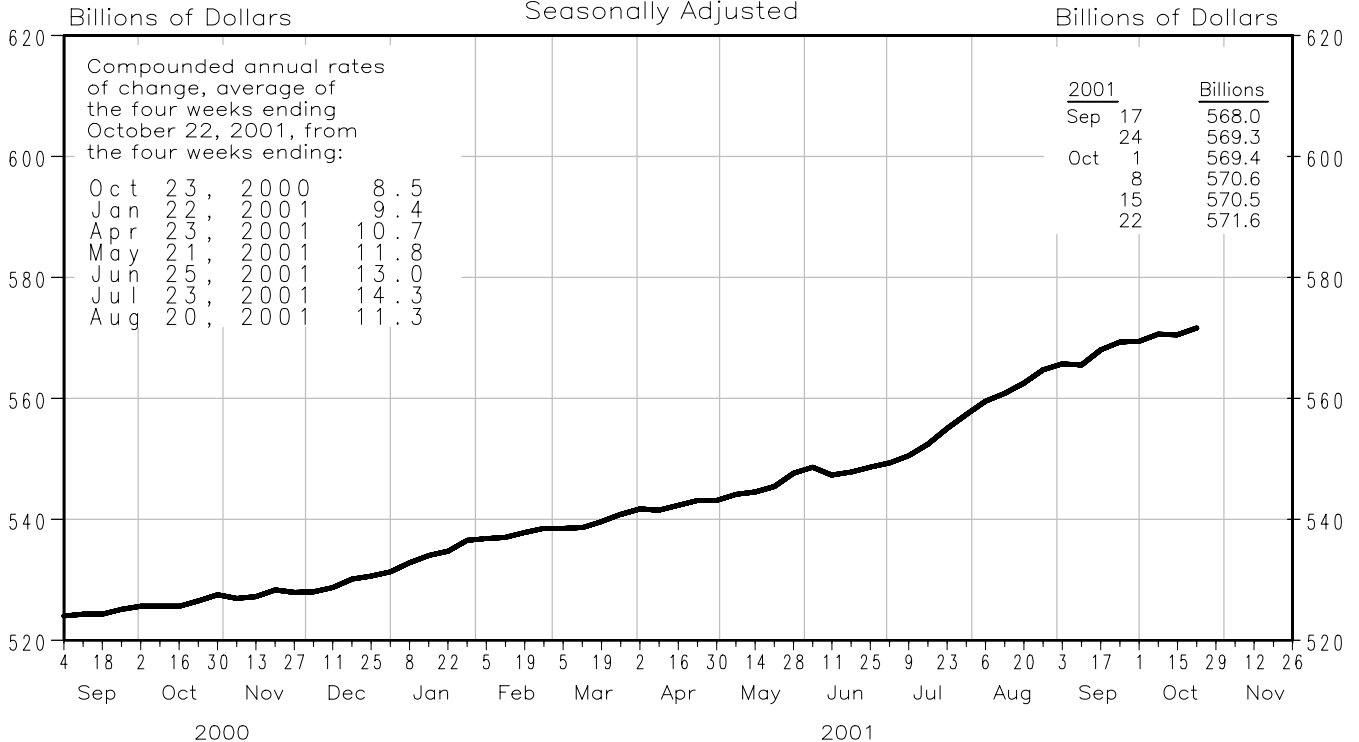

## Currency Component of M1

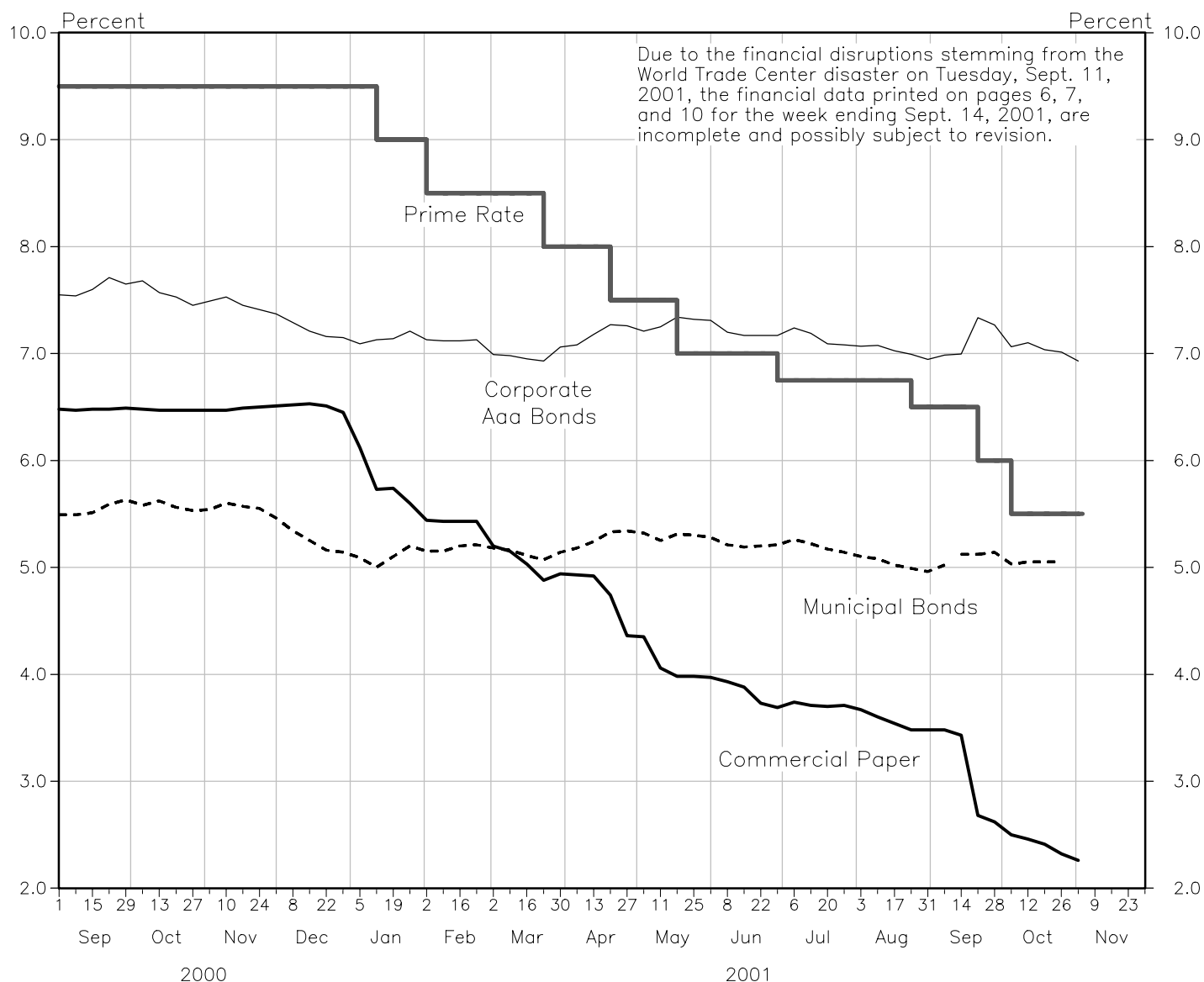

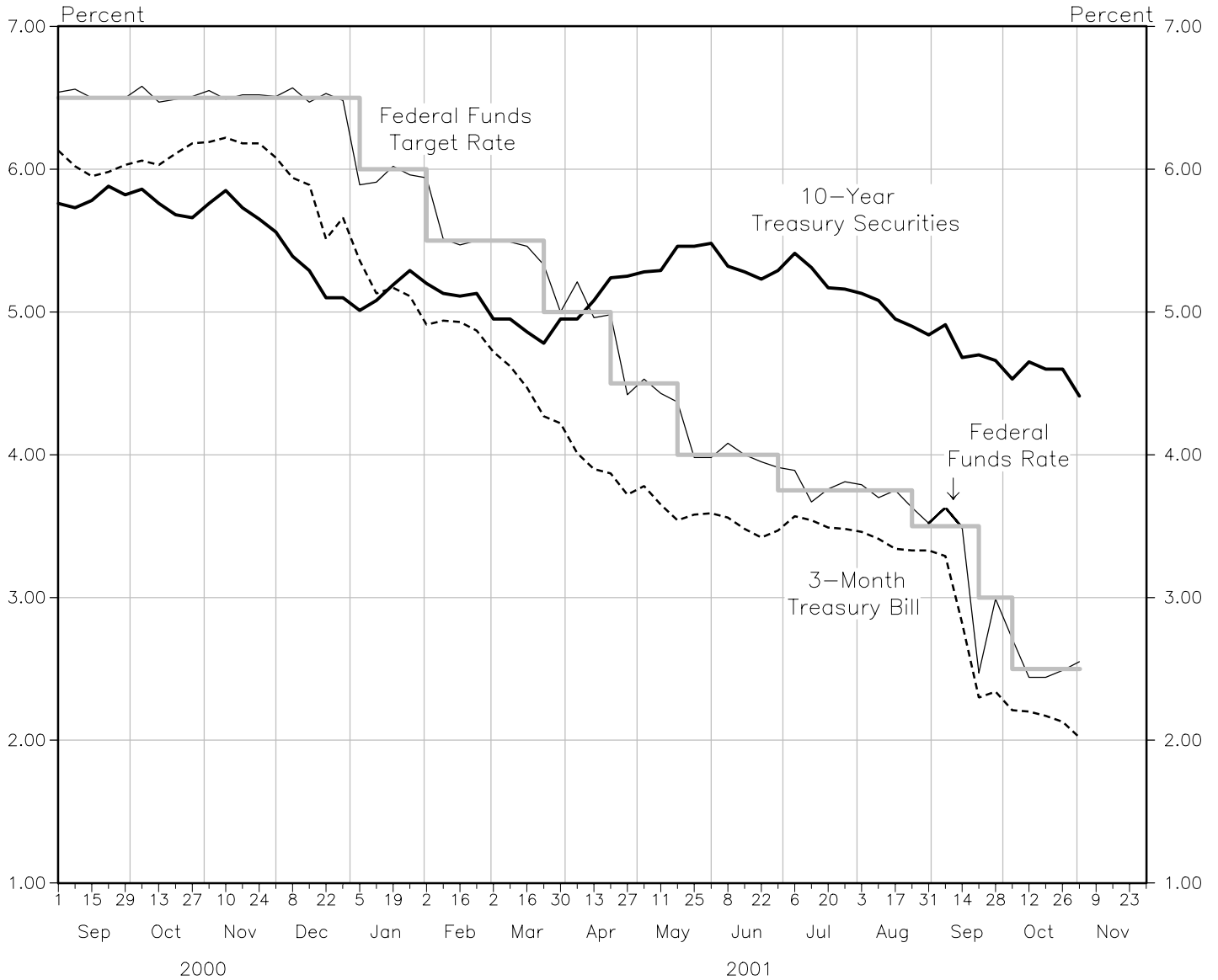

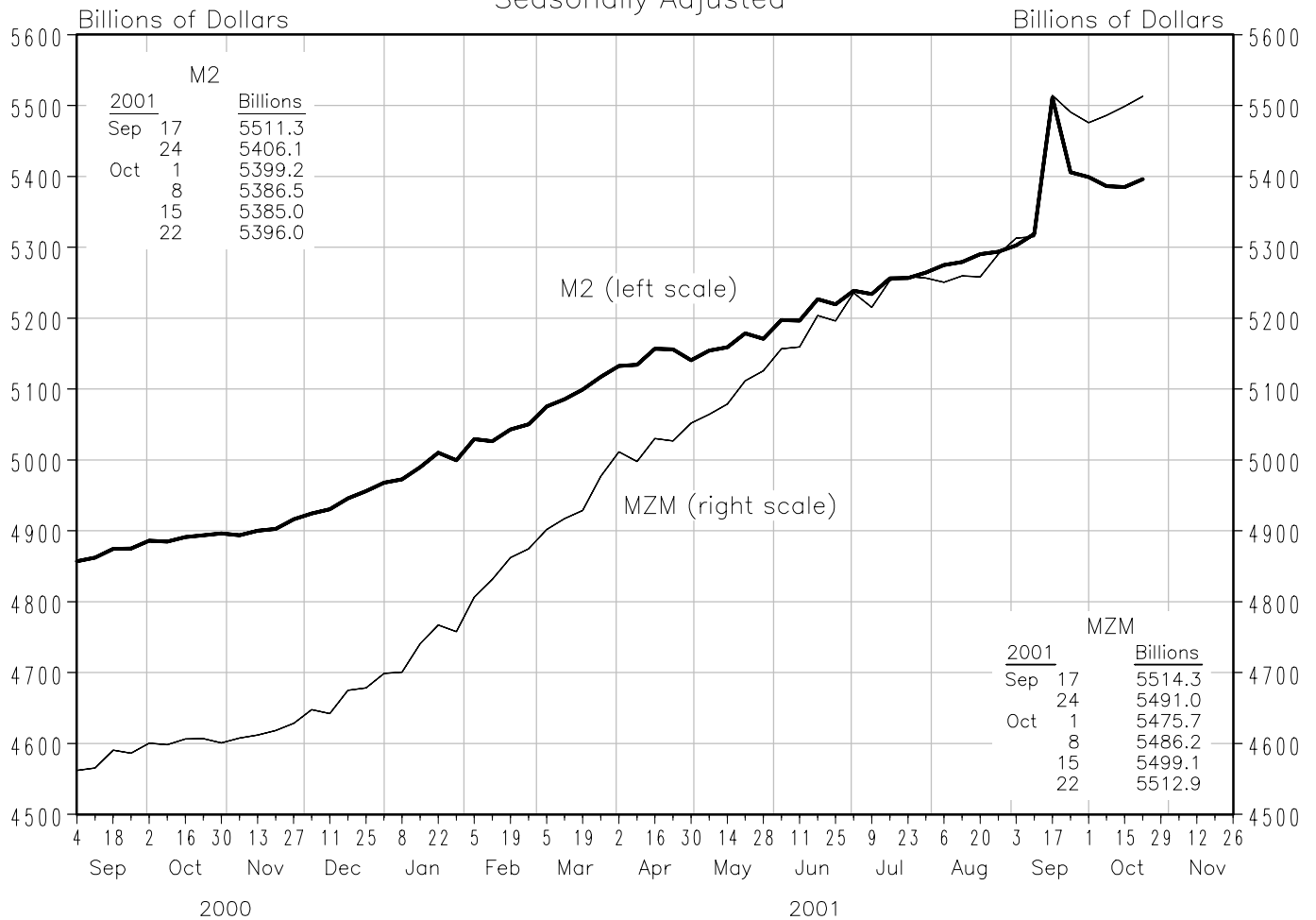

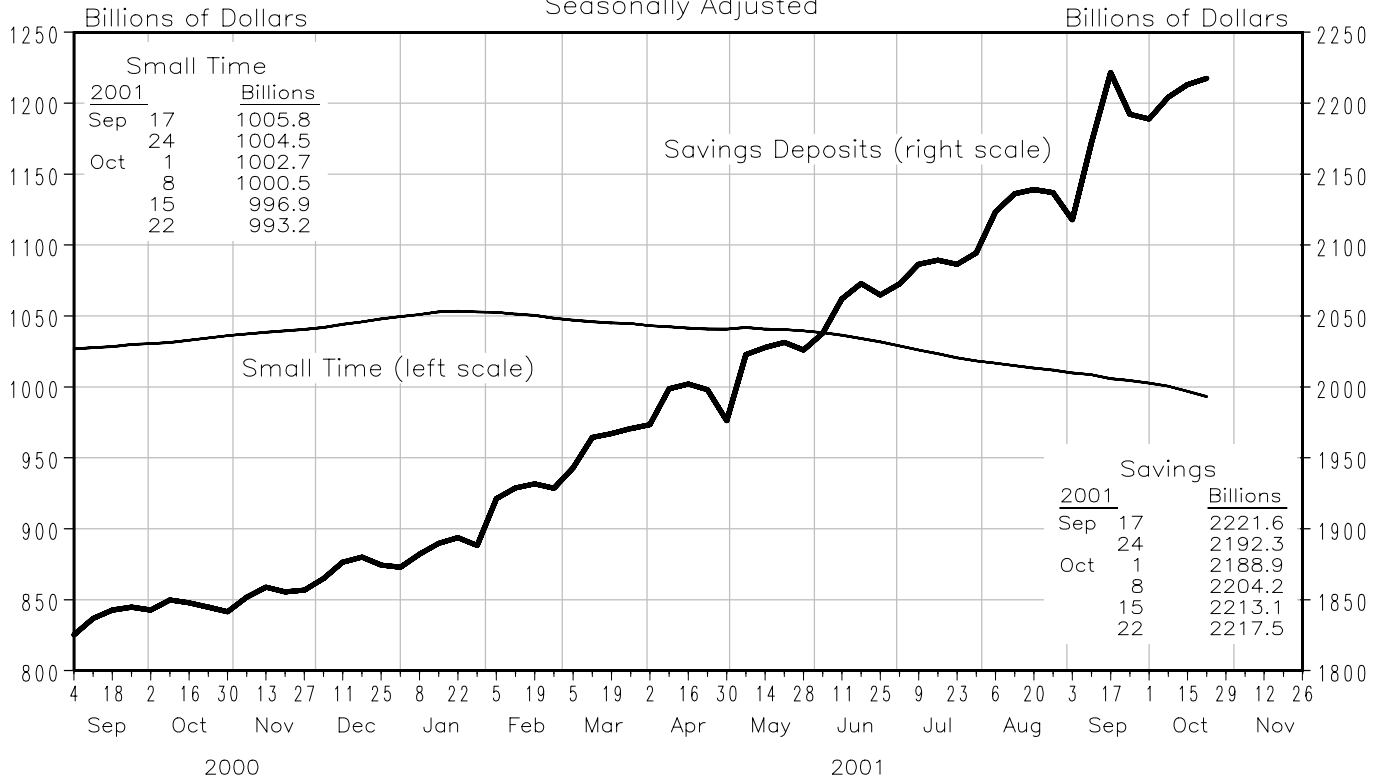

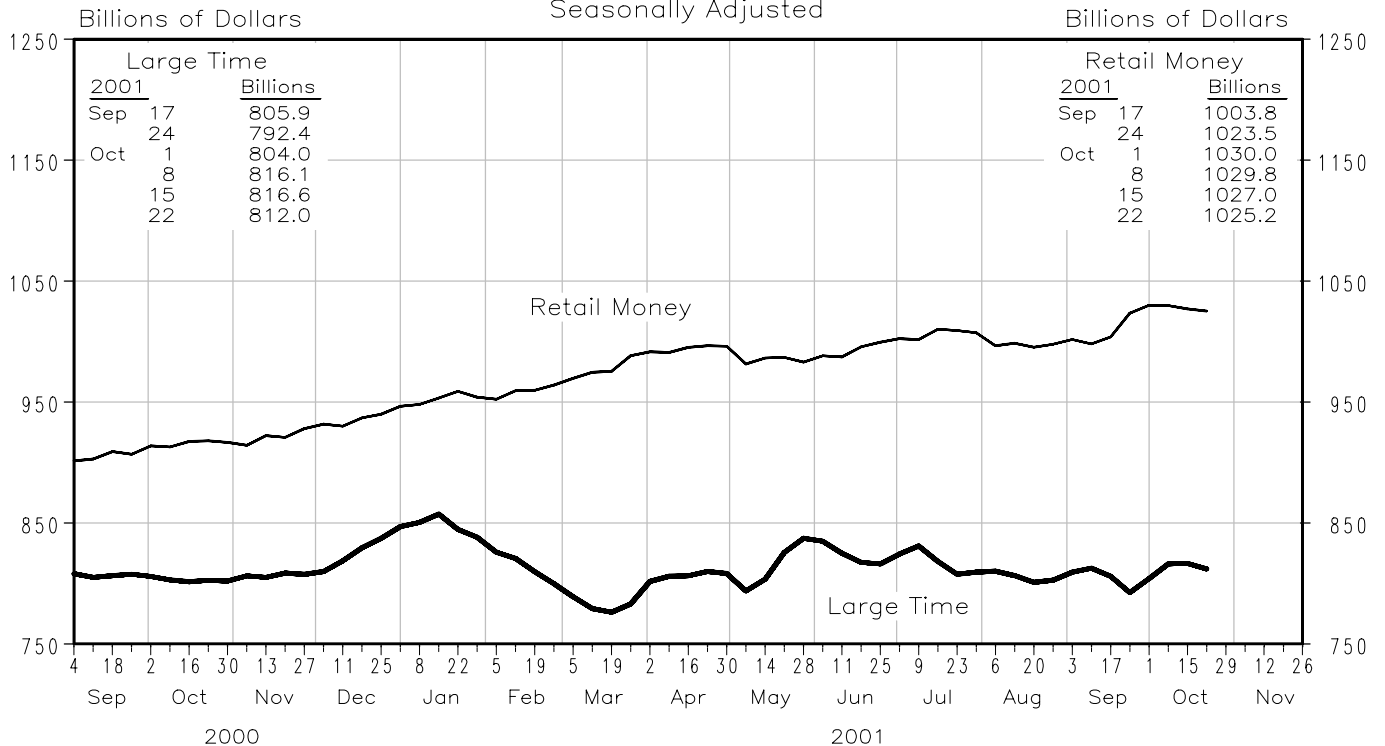

# Large Time Deposits and Retail Money Funds

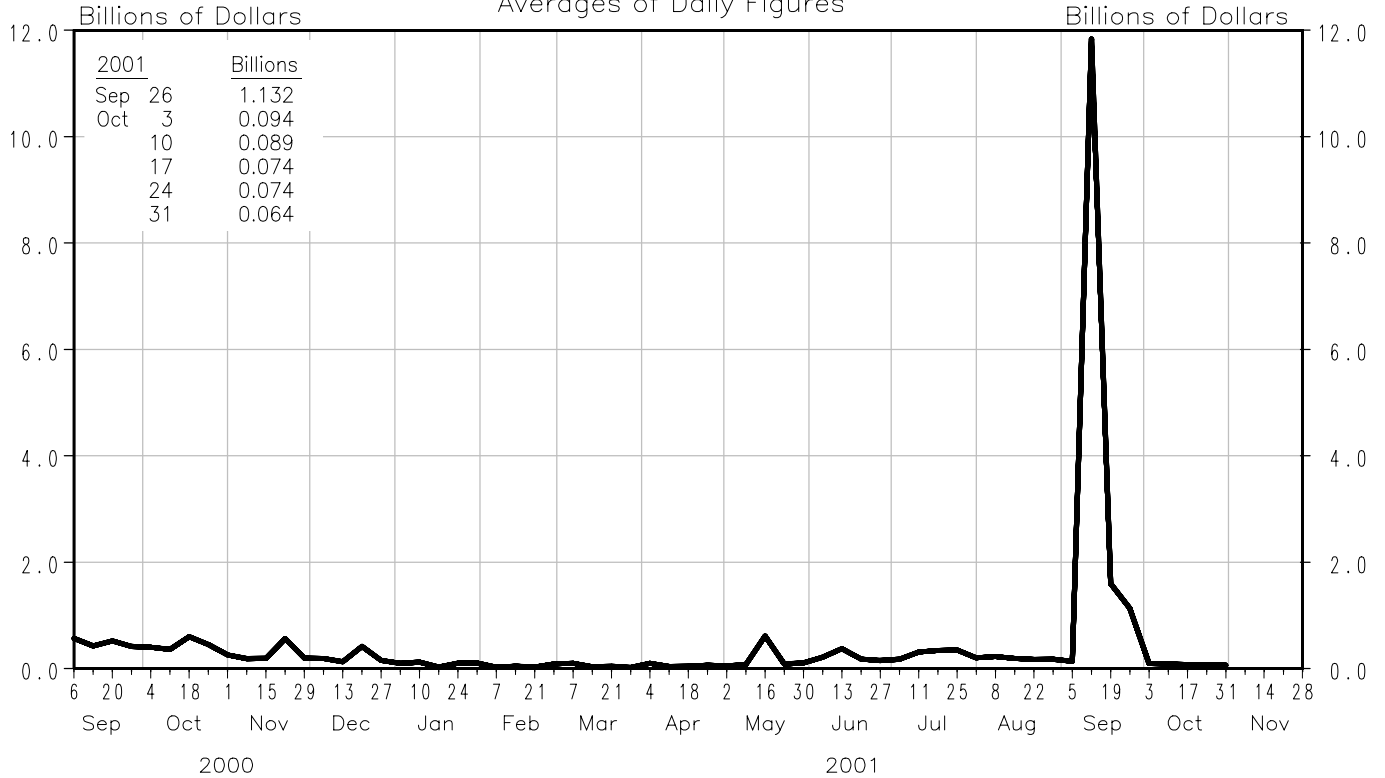
Averages of Daily Figures

# Total Borrowings

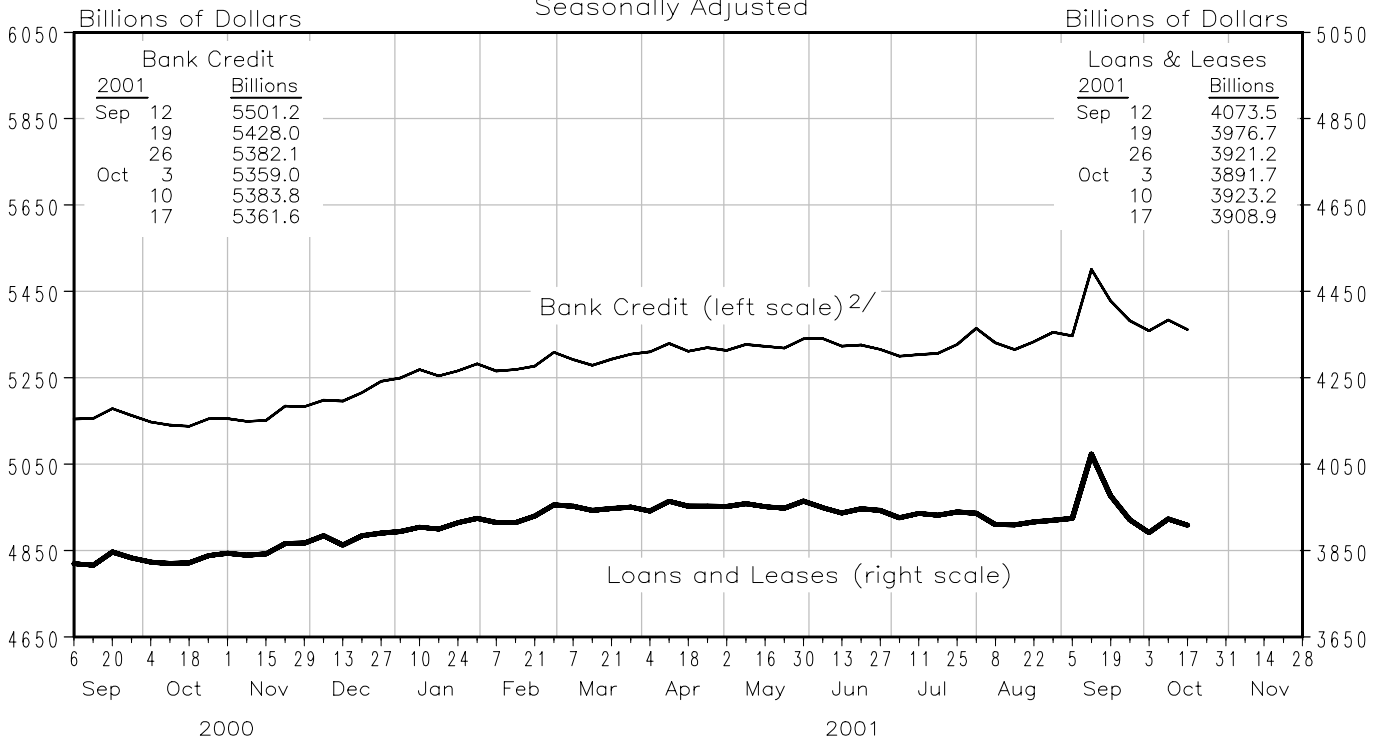

Seasonally Adjusted



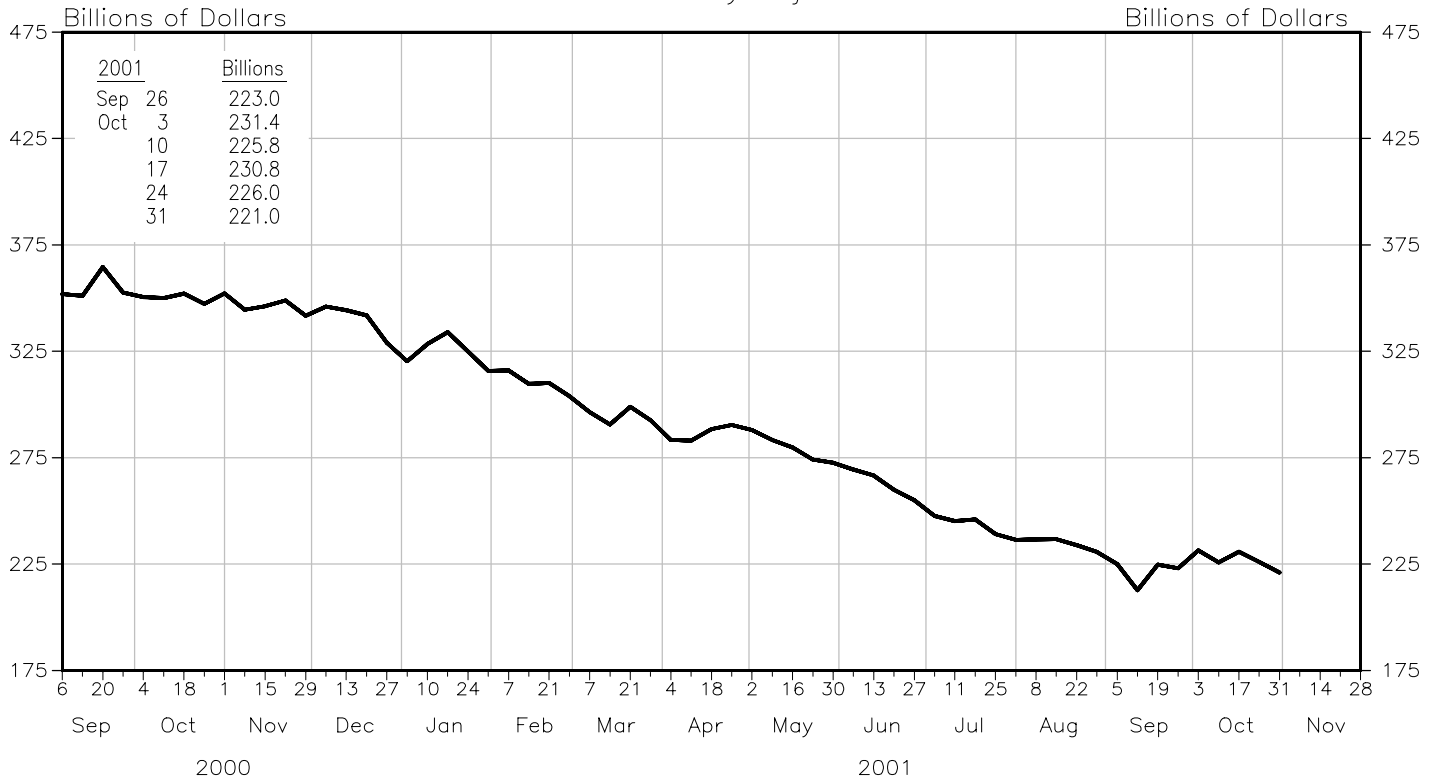

# Commercial Paper of Nonfinancial Companies

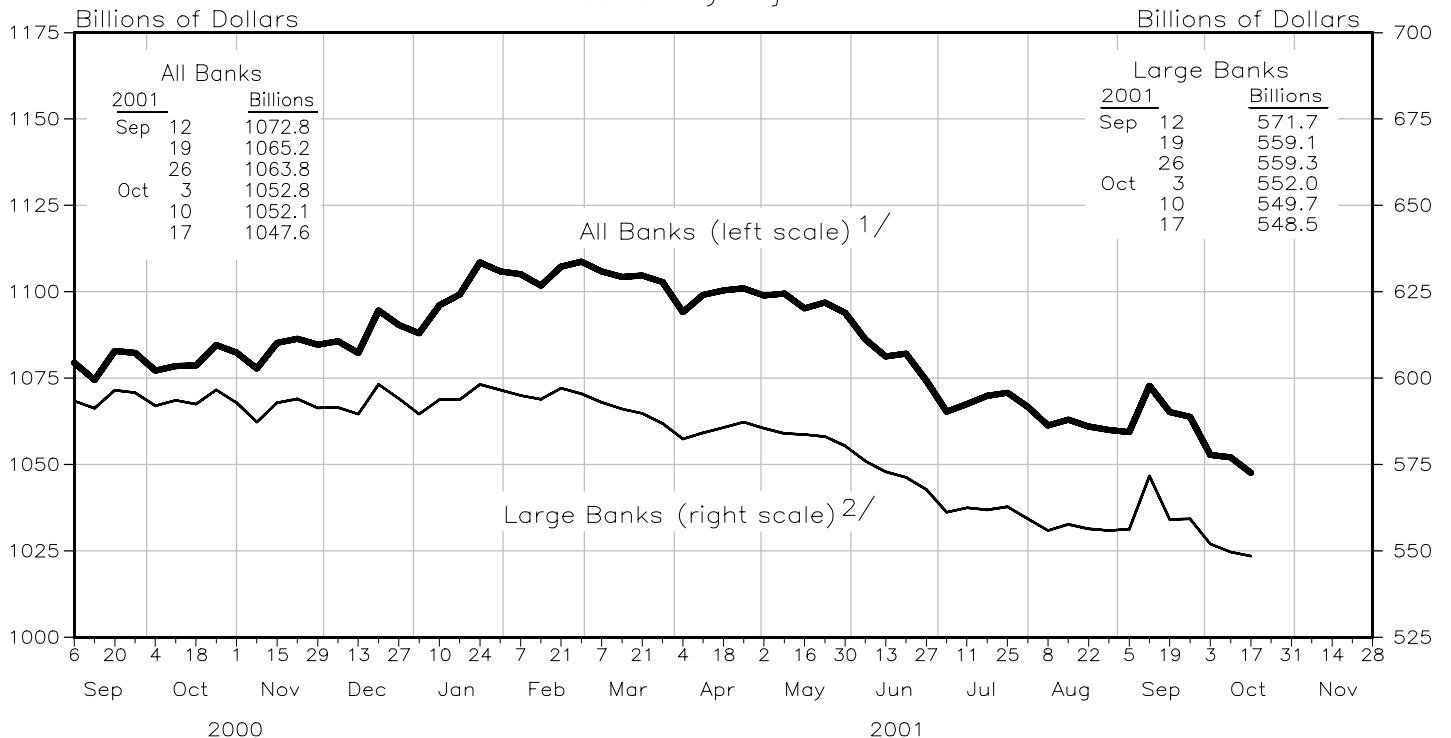
Not Seasonally Adjusted

Seasonally Adjusted



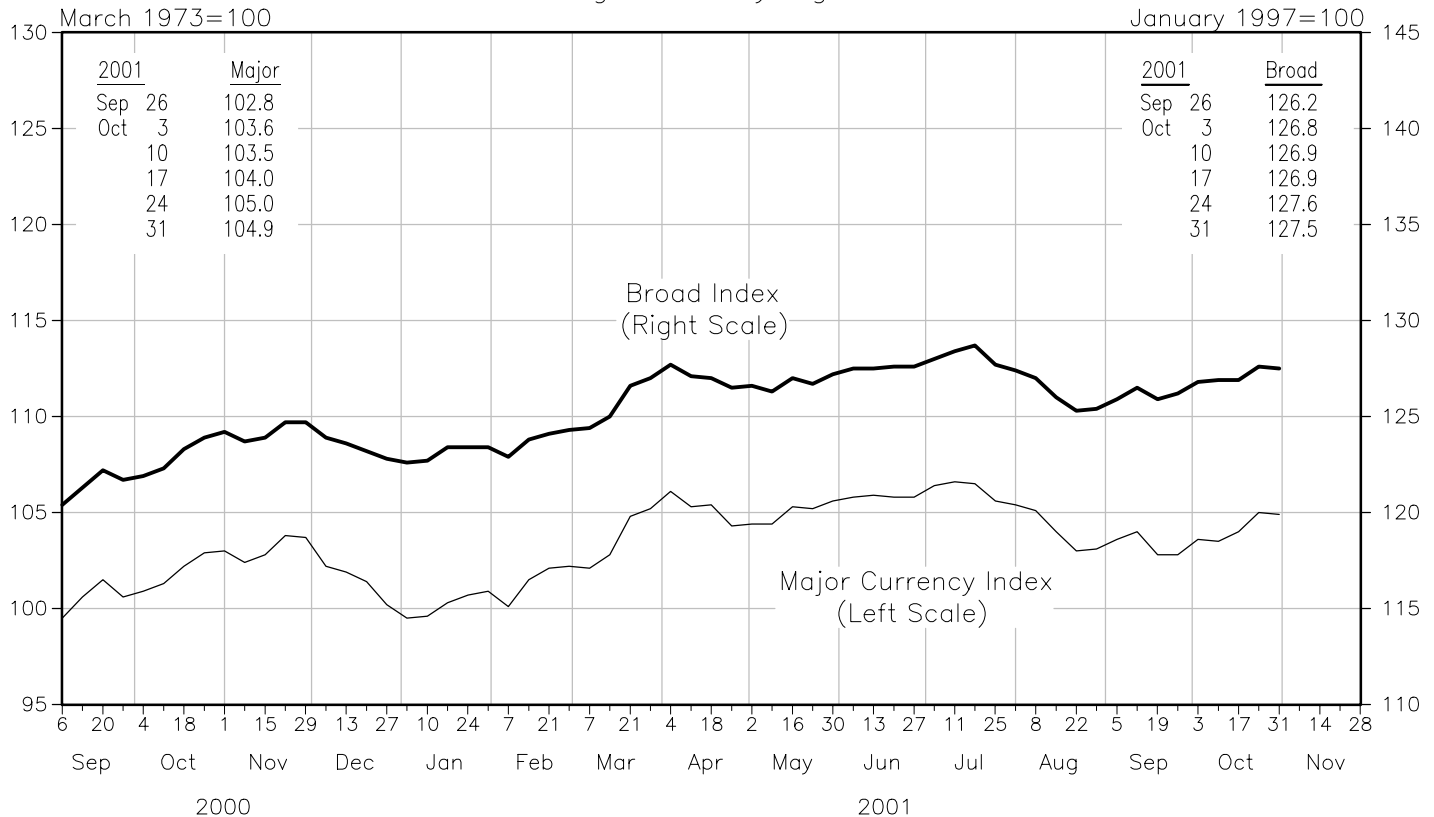
