### **Ensuring Equity in Infrastructure**



Acting Secretary Julie Su continued her Good Jobs Summer tour to promote the Department of Labor's <u>Good Jobs</u> Principles and meet with workers who are benefitting from the Biden-Harris administration's investments in the United States' roads and bridges, manufacturing base and clean energy economy. In Phoenix she visited the Fresh Start Women's Foundation, WB's grantee through the <u>Women in Apprenticeship and Nontraditional Occupations (WANTO) grant program</u>, and met a group of women who received training, financial counseling, legal services and other resources and are now working in high-paying fields.

## Eliminating Gender-Based Violence and Harassment in the World of Work



Women's Bureau staff traveled to Chicago to present on gender-based violence and harassment and how it affects workers' health and safety at the 2024 International UAW Women's and TOP Conference, also attended by Acting Secretary Su. Unions and unionized workers have a key role to play in the adoption of workplace policies that prevent and address gender-based violence and harassment. Over the past year, WB staff have hosted more than 40 convenings on the topic and received a positive response from unions and union women.
