President Roosevelt Allocates \$125,773 for Bridge Construction in Vermont and Pennsylvania.

The President today allocated \$125,773 from the funds of the Emergency Relief Appropriation Act of 1936 to reconstruct or replace bridges damaged or destroyed by floods in Vermont and Pennsylvania.

Vermont received an allocation of \$4,678 and Pennsylvania \$121,095.

The projects will be carried on under the supervision of the Bureau of Public Roads, Department of Agriculture. Treasury warrants have been countersigned by the Comptroller General.
