AVERAGES OF DAILY FIGURES FOR MEMBER BANKS AND AVERAGES OF CURRENT AND PREVIOUS MONTH-END DATA FOR FOREIGN-RELATED INSTITUTIONS. AFTER OCTOBER, 1980, MOVEMENT IN FEDERAL FUNDS, RPS, AND OTHER BORROWINGS FROM NONBANKS IS BASED ON FLUCTUATIONS IN SECURITY RPS AND BORROWINGS FROM UNAFFILIATED FOREIGN SOURCES, FEDERAL RESERVE BANKS, AND FEDERAL AGENCIES.
