Unless otherwise indicated, all transactions involve the bank's common stock. Any indirect interest (through holding companies, partmerships, trusts, family ownership, etc.) is shown below the direct interest. Symbols indicate the nature of the transactions, if other than a purchase or sale, and the nature of ownership, if other than direct (see "Guide to Symbols" below).
