CONSUMER INSTALLMENT CREDIT May 1992

Consumer installment credit outstanding declined \$2.4 billion in May, following a \$3.6 billion drop in April. Auto loans fell \$1.7 billion in May, about the same as in April; other loans outstanding also declined, but by less than in April. Growth in revolving credit was weak.

Interest rates at commercial banks are simple unweighted averages of each bank's most common rate charged during the first calendar week of the middle month of each quarter. Finance company data are from the subsidiaries of the three major U.S. automobile manufacturers and are volume-weighted averages covering all loans of each type purchased during the month.

^{4.} Outstanding balances of pools upon which securities have been issued; these balances are no longer carried on the balance sheets of the loan originators.

^{5.} Includes estimates for holders that do not separately report consumer credit holding by type.
