Revision of previous reports

The statement covering the month of October 1949 reported that the Union National Bank, Charlotte, North Carolina, had opened a branch at 406 North Tryon Street on October 15, 1949, known as Uptown Drive-In Office. Advice has now been received that this branch did not open for business until November 29, 1950, and that due to renumbering of the street the address is 408 North Tryon Street.
