Revision of dates shown in October 1951 report

Merger: The statement reported the merger of Lee County Commercial Bank and Peoples Exchange Bank, both located in Beattyville, Ky., on September 28, 1951. Advice has now been received from the Federal Deposit Insurance Corporation that this merger did not become effective until December 21, 1951.

Branch opening: The statement also reported that the Guaranty Bank & Trust Co., Alexandria, Louisiana, opened a de novo branch at 818 Fourth Street, Alexandria on October 15, 1951; we are now advised that this branch did not open for business until December 5, 1951.
