BANK DEBITS

Debits to individual accounts, as reported by banks in leading cities for the week ending March 19 aggregated \$10,107,000,000 or about 12 per cent above the total of \$9,033,000,000 reported for the preceding week. The large increase is due in part to the usual heavy mid-month payments and in part to the charging of checks in payment for income taxes due March 15. New York City reports an increase of \$590,000,000, Boston - an increase of \$67,000,000 and Philadelphia - an increase of \$66,000,000.

As compared with the corresponding period in 1923, debits for the week under review show a decrease of \$101,000,000, or of about 1 per cent. New York City shows a decrease of \$132,000,000 and Boston - a decrease of \$19,000,000. An increase of \$44,000,000 is reported for Los Angeles.

Aggregate debits for 141 centers for which figures have been published weekly since January, 1919, were \$9,516,434,000 as compared with \$8,488,224,000 for the preceding week and \$9,597,931,000 for the week ending March 21, 1923.

Debits to individual accounts were reported to the Federal Reserve Board for banks in 255 centers, of which 247 are included in the summary by Federal reserve districts.
