BANK DEBITS

Debits to individual accounts, as reported to the Federal Reserve Board by banks in leading cities for the week ending December 29, 1926, aggregated \$11,769,000,000 or 16.9 per cent below the total of \$14,160,000,000 reported for the preceding week. The current week included but five business days on account of the holiday on December 25.

Total debits for the week under review are \$968,000,000 or 9 per cent above those for the week ending December 30, 1925, which also included but five business days. New York reported an increase of \$637,000,000, Philadelphia \$73,000,000, Chicago \$57,000,000, Boston \$41,000,000, San Francisco \$32,000,000 and Cleveland \$25,000,000.

Aggregate debits for 141 centers for which figures have been published weekly since January 1919 amounted to \$11,101,600,000 compared with \$13,334,544,500 for the preceding week and \$10,181,126,000 for the week ending December 30, 1925.
