(Averages for week ending Wednesday, ratio scale, March 1973 = 100)

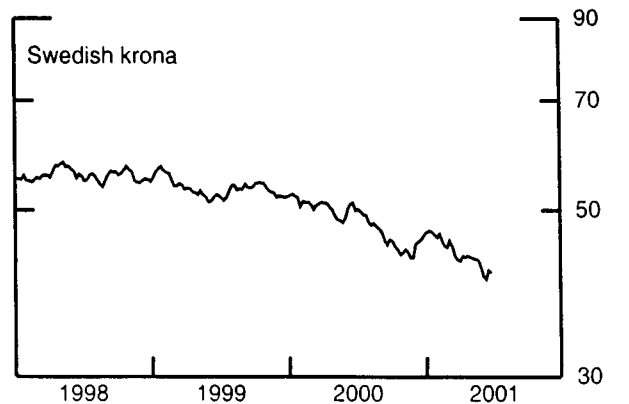
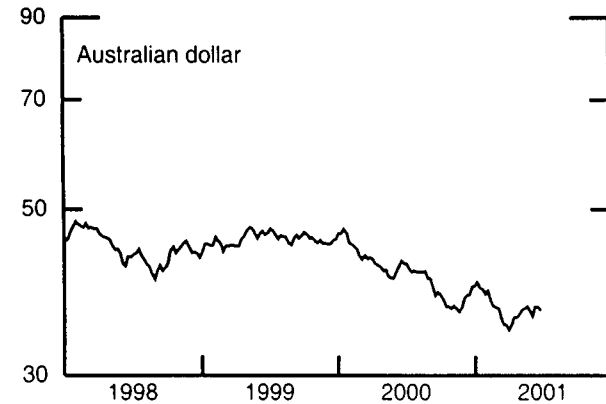
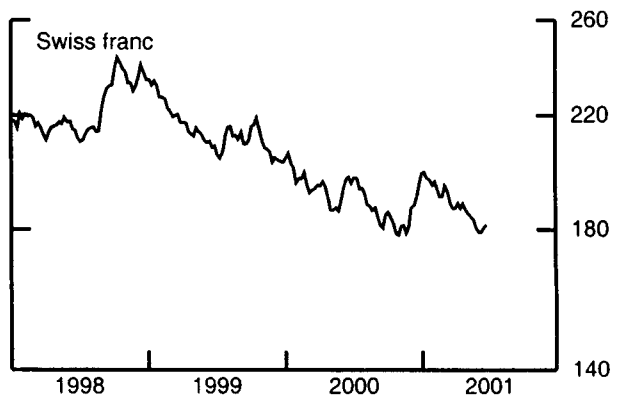
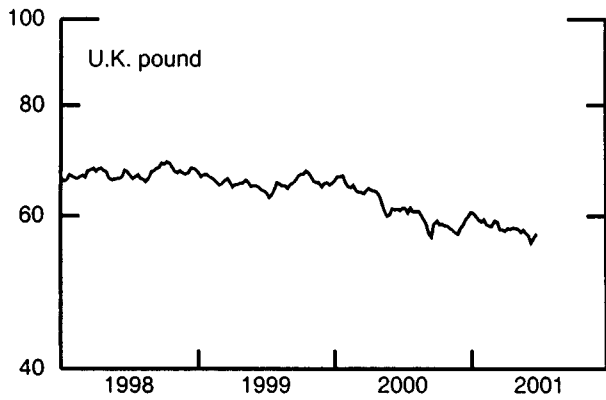
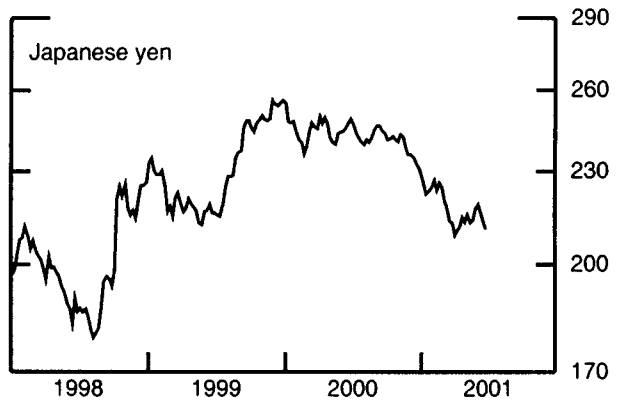
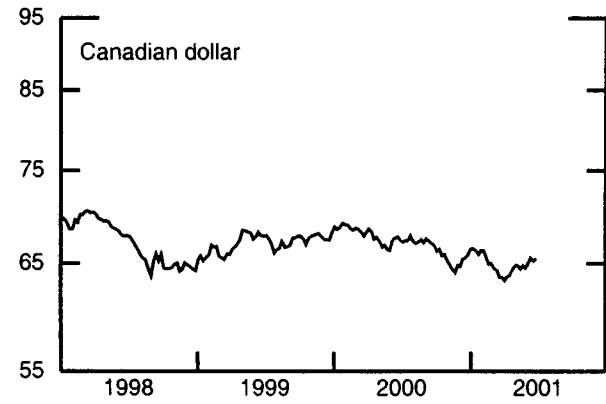
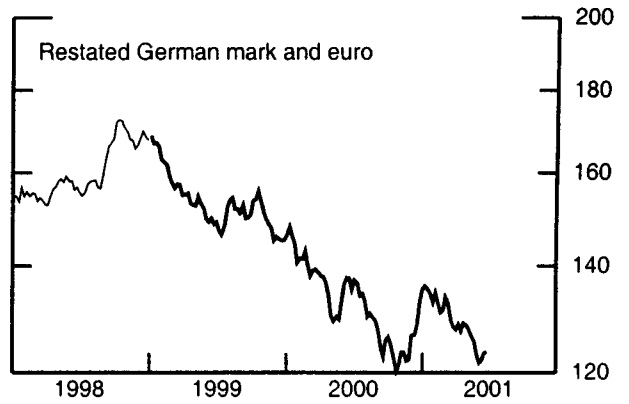
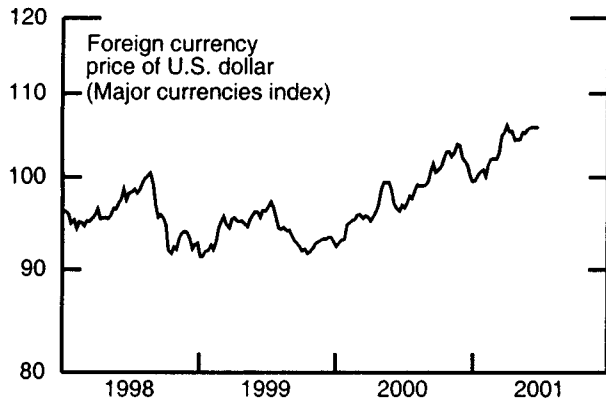

(Averages for week ending Wednesday, percent per annum)

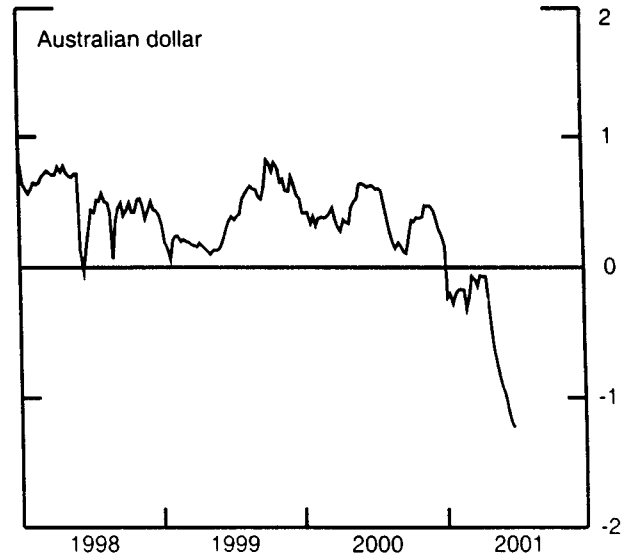
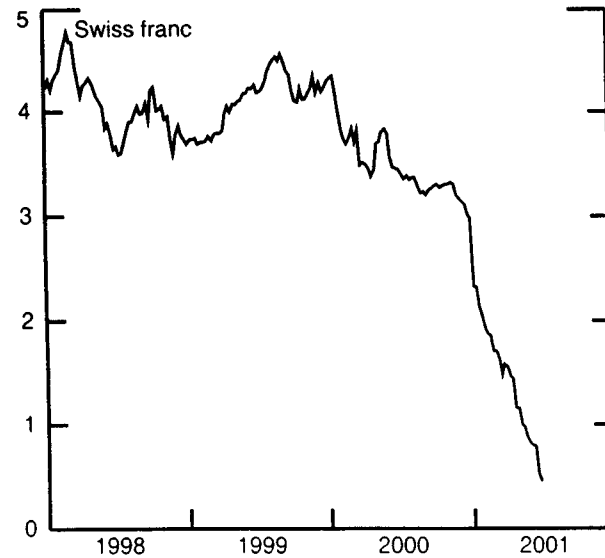
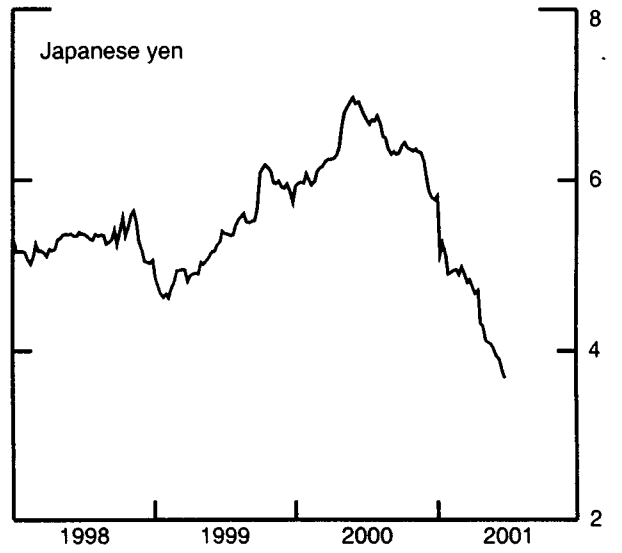
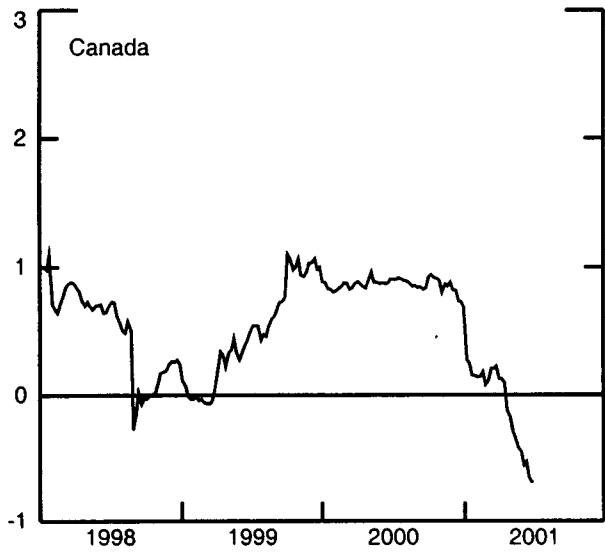
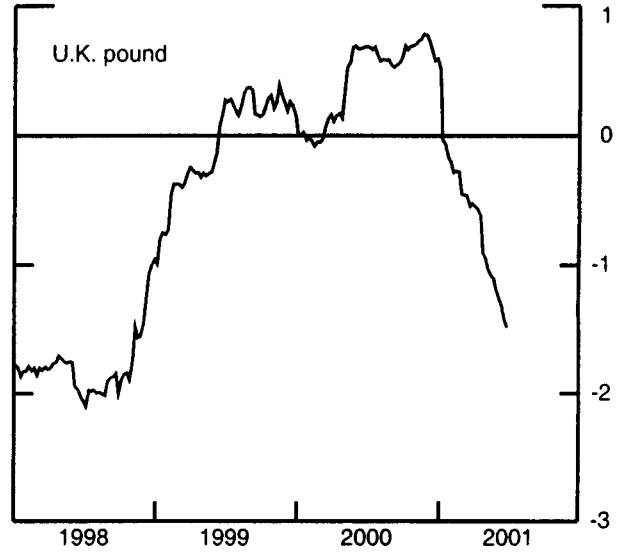

(Averages for week ending Wednesday)

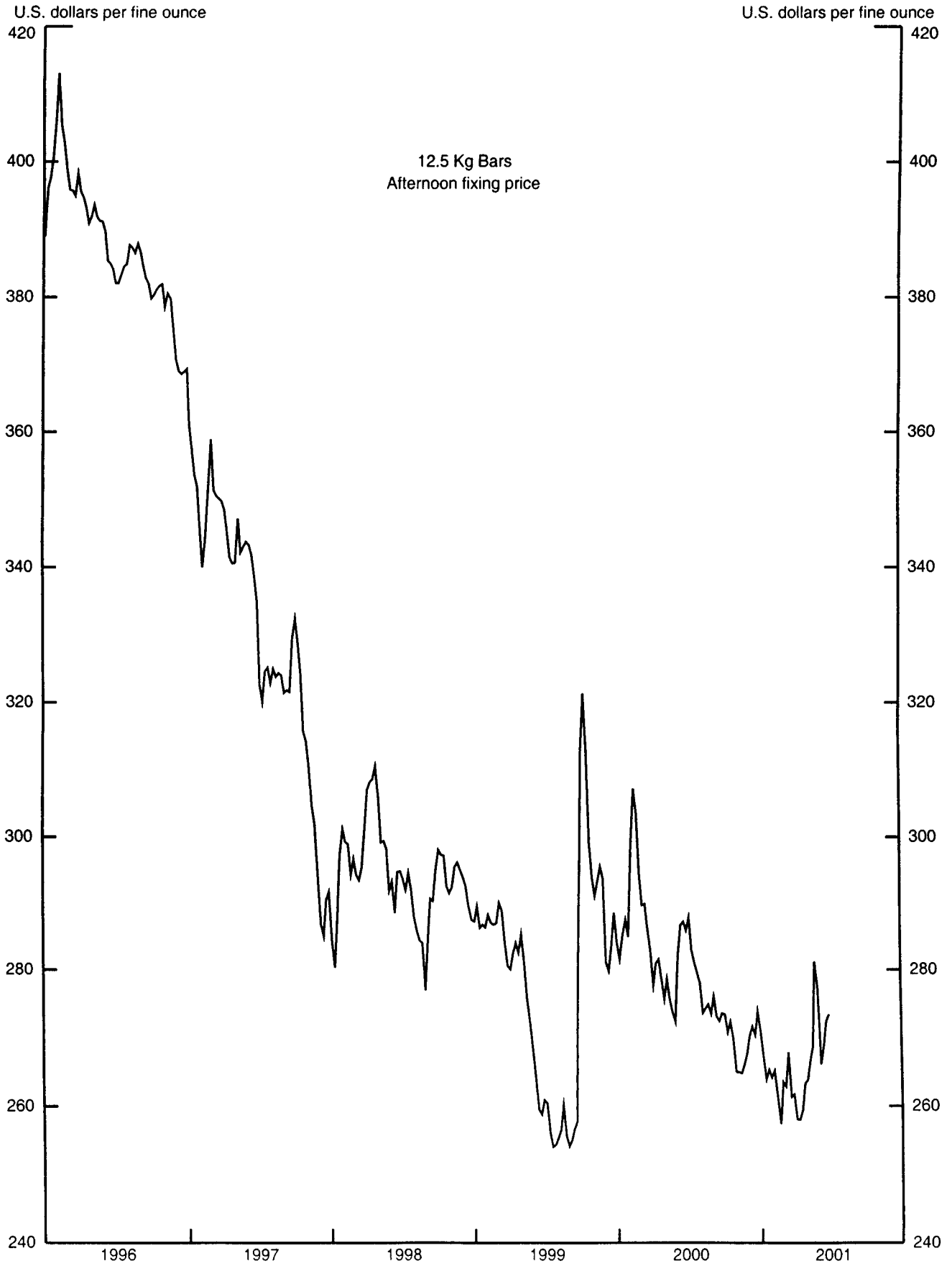
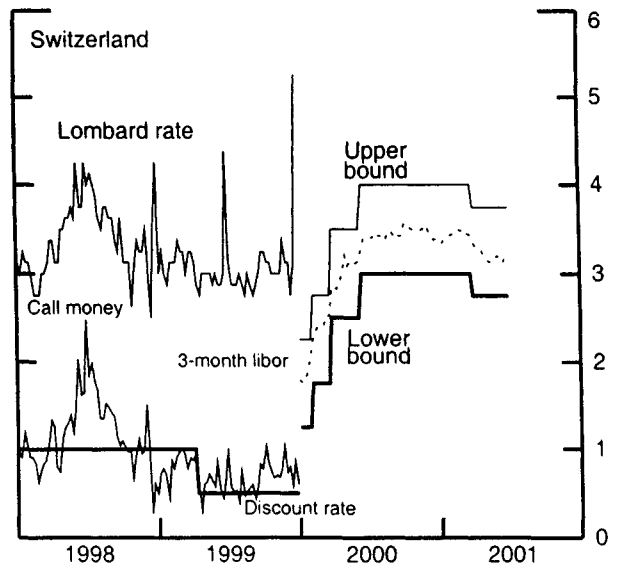
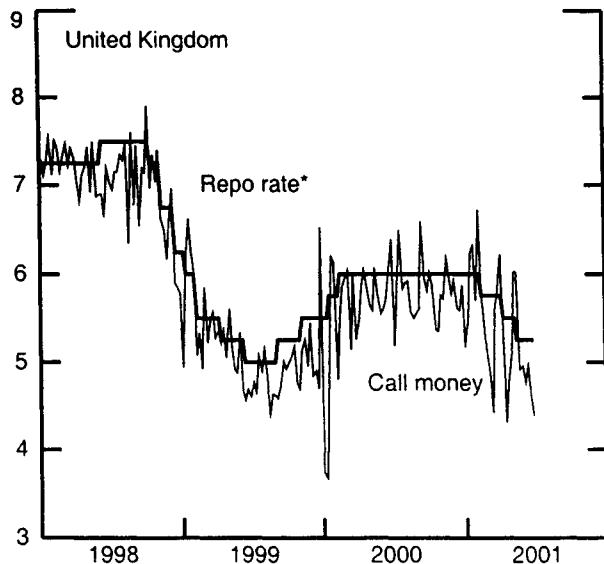
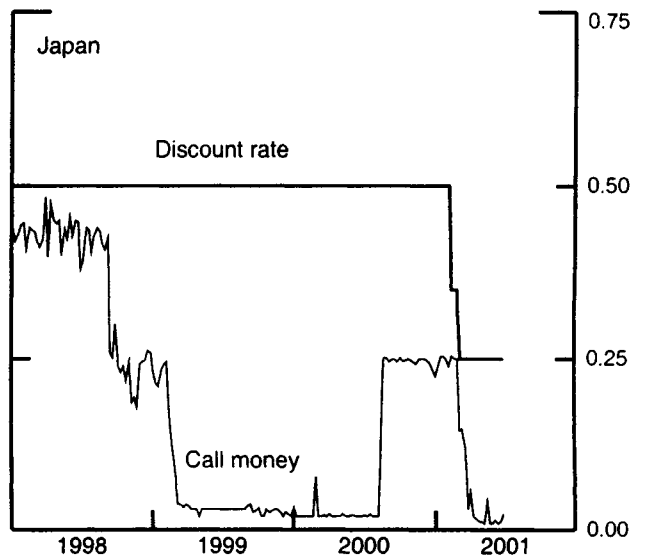
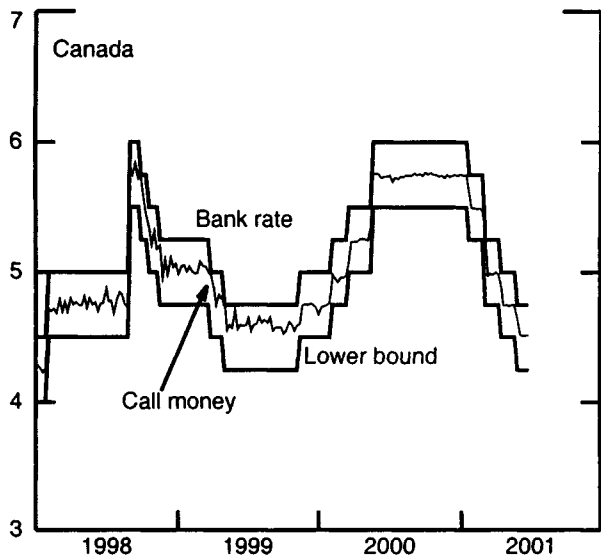
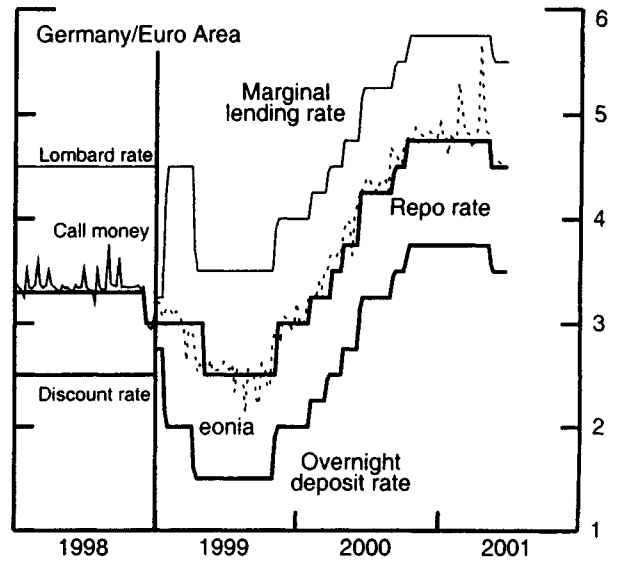
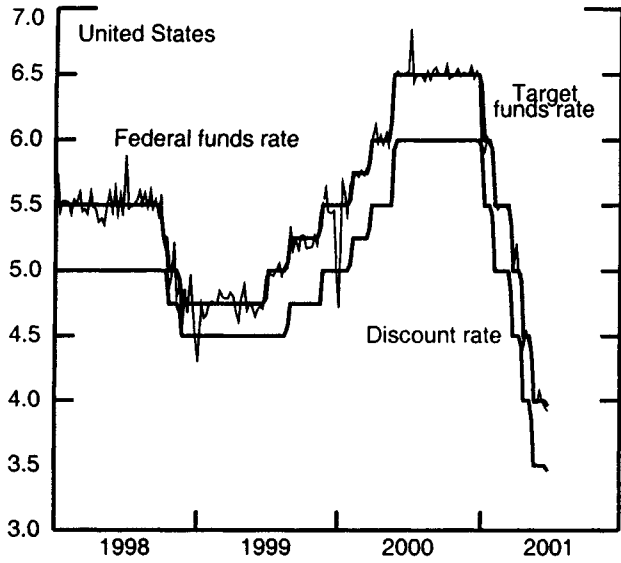

(Averages for week ending Wednesday, percent per annum)

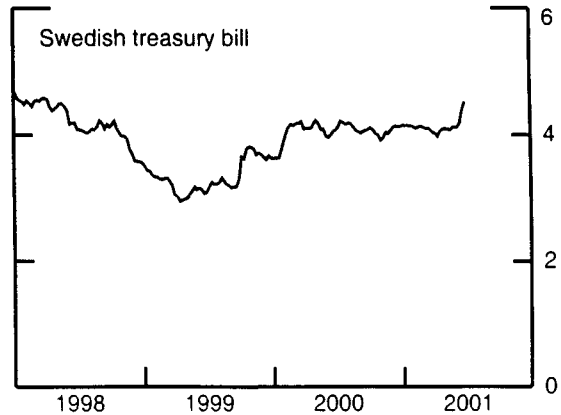
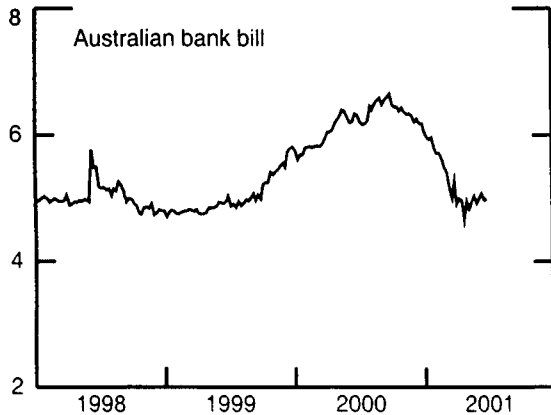
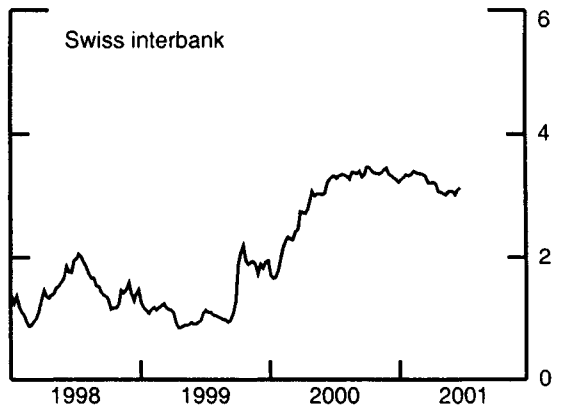
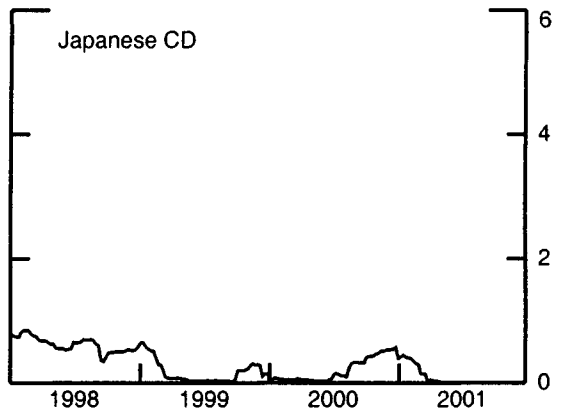
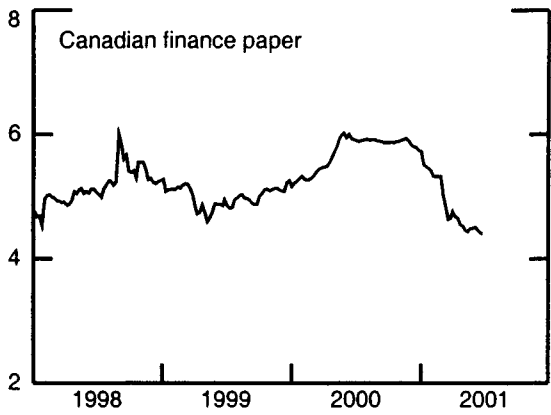
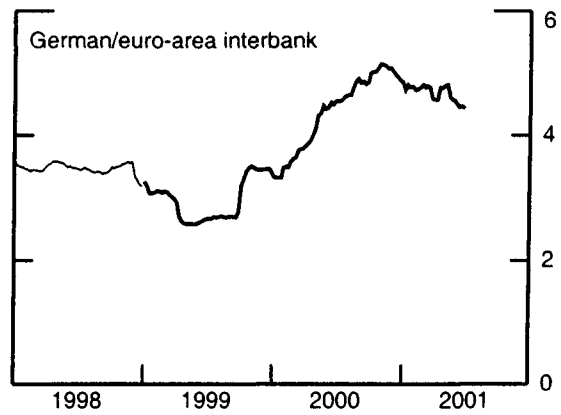
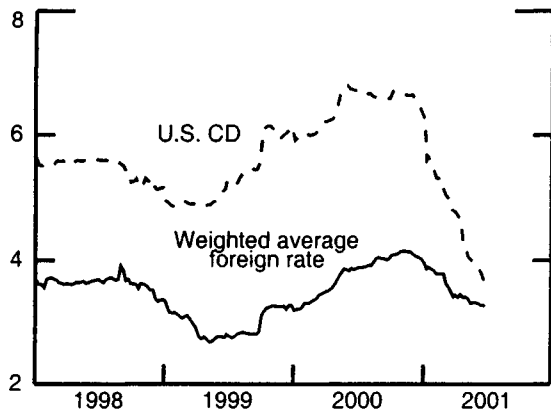

Long-Term Government Bond Yields (Averages for week ending Wednesday, percent per annum)

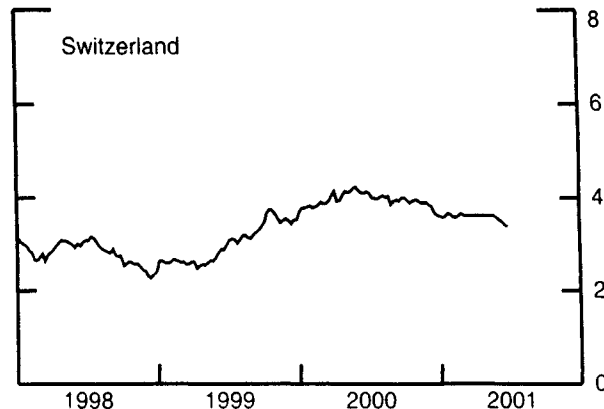
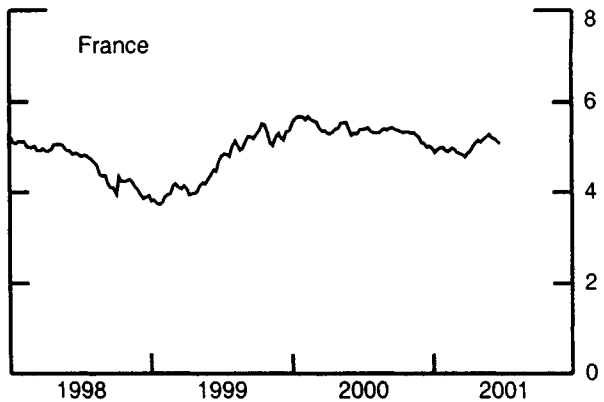
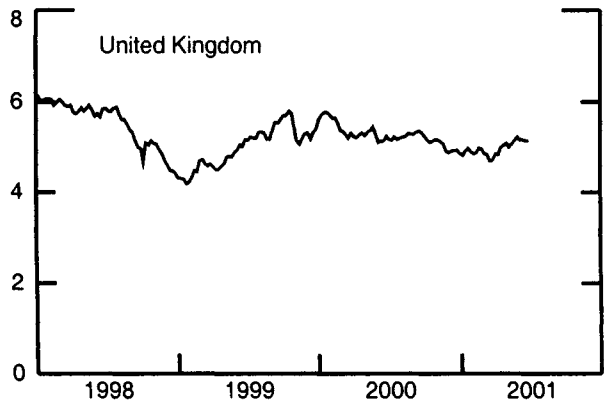
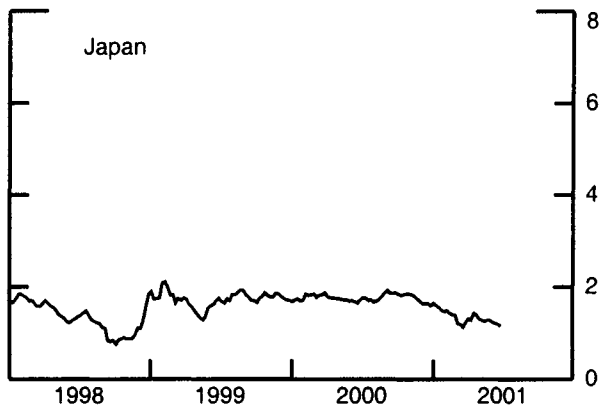
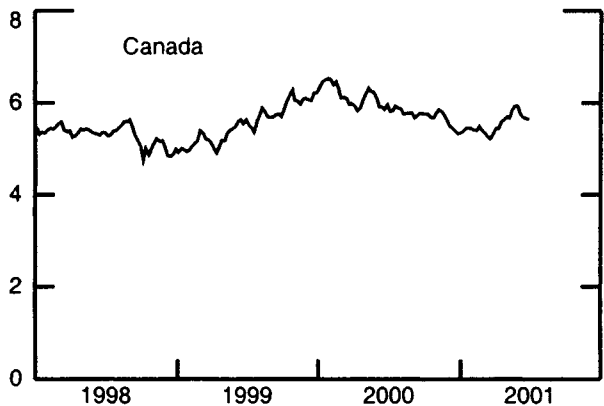
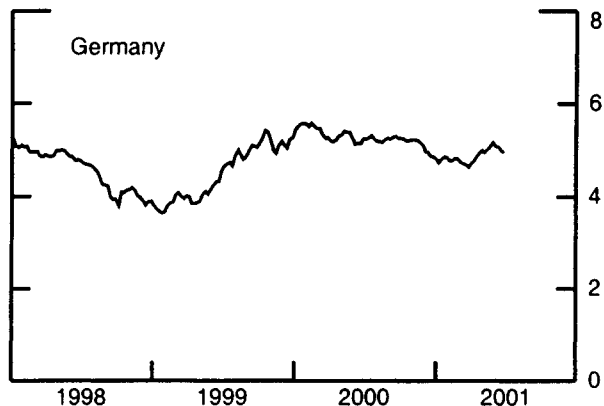
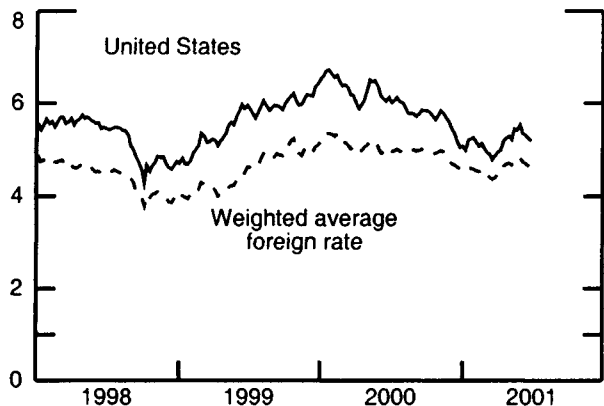
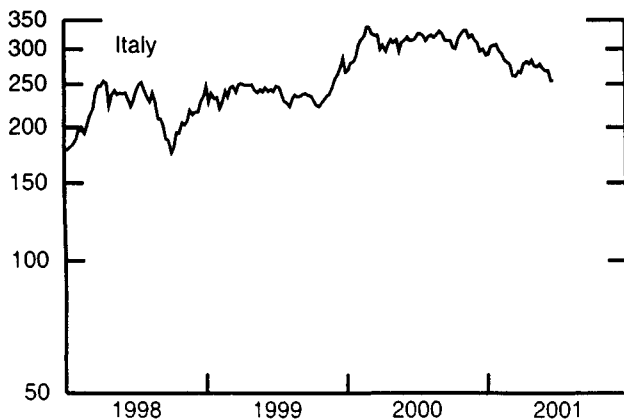
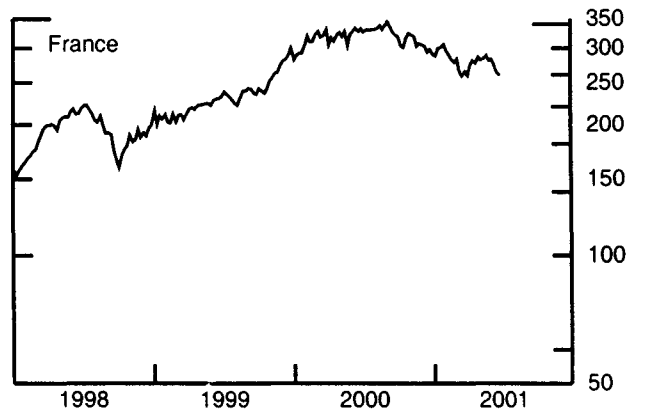
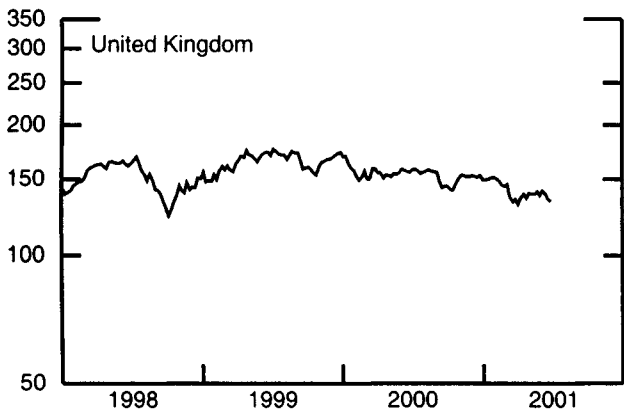
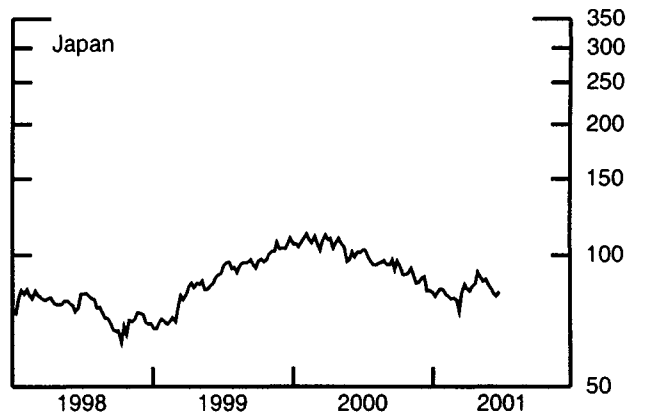
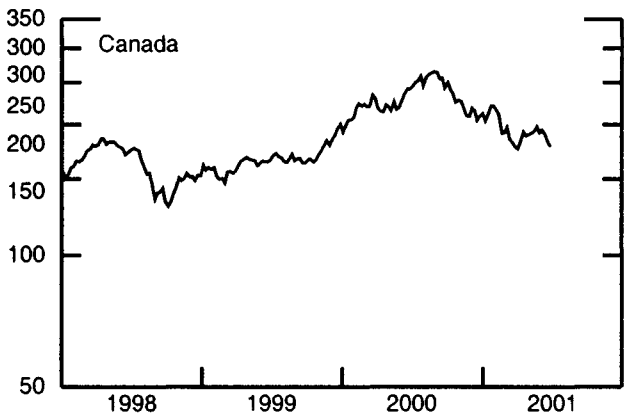
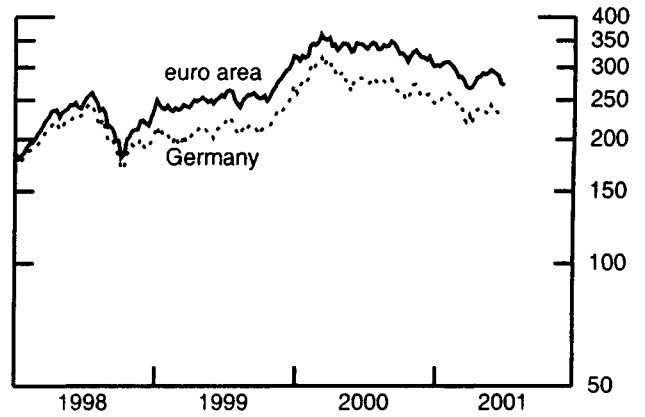
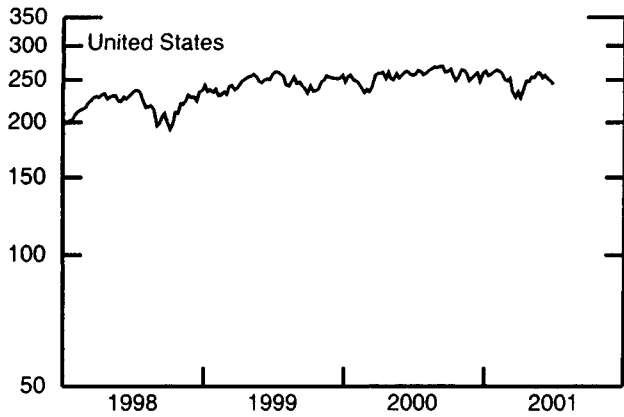
