(Average for week ending Wednesday, ratio scale, March 1973 = 100)







Averages for week ending Wednesday, percent per annum)







(Averages for week ending Wednesday)





Interbank Funding Rates and Official Interest Rates

(Averages for week ending Wednesday, percent per annum)










(Averages for week ending Wednesday, percent per annum)












