1. The daily effective federal funds rate is a weighted average of rates on trades through N.Y. brokers.

DESCRIPTION OF THE TREASURY CONSTANT MATURITY SERIES

Yields on Treasury securities at "constant maturity" are interpolated by the U.S. Treasury from the daily yield curve. This curve, which relates the yield on a security to its time to maturity, is based on the closing market bid yields on actively traded Treasury securities in the over-the-counter market. These market yields are calculated from composites of quotations reported by five leading U.S. Government securities dealers to the Federal Reserve Bank of New York. The constant maturity yield values are read from the yield curve at fixed maturities, currently 1, 2, 3, 5, 7, 10, 20, and 30 years. This method provides a yield for a 10-year maturity, for example, even if no outstanding security has exactly 10 years remaining to maturity. In estimating the position of the daily yield curve at a maturity of 20 years, the Treasury began, on October 1, 1993, to incorporate the prevailing market yield on an outstanding Treasury bond with approximately 20 years to maturity. The Treasury had been linearly interpolating between 10- and 30-year maturities since May 1986, owing to a scarcity of securities trading in the 20-year area after it ceased issuing 20-year bonds earlier that year.
