The First National Bank of Tampa, Tampa, Florida, and Union Security & Investment Co., Tampa, Florida, for prior approval for each to become a bank holding company as a result of the acquisition by Union Security & Investment Co. of 20,000 of the 25,000 shares of Second National Bank of Tampa, Tampa, Florida (a proposed new bank). Upon consummation of the acquisition proposed, each applicant would become a bank holding company inasmuch as Union Security & Investment Co. now owns more than 25 per cent of The Broadway National Bank of Tampa, Tampa, Florida, and all the shares of Union Security & Investment Co. are held in trust for the benefit of the shareholders of The First National Bank of Tampa.
