CONDITION OF THE FEDERAL RESERVE BANKS

During the week ended February 23 member bank reserve balances decreased \$6,000,000. Reductions in member bank reserves resulted from increases of \$71,000,000 in money in circulation, \$22,000,000 in nonmember deposits and other Federal Reserve accounts, and \$3,000,000 in Treasury cash and a decrease of \$79,000,000 in Reserve Bank credit offset in part by a decrease of \$163,000,000 in Treasury deposits with Federal Reserve Banks and an increase of \$6,000,000 in gold stock. Excess reserves of member banks on February 23 were estimated to be approximately \$620,000,000.

Holdings of loans, discounts and advances increased \$65,000,000 and of United States Government securities \$55,000,000. The increase in holdings of United States Government securities reflects increases of \$93,000,000 in certificates and \$35,000,000 in bills and decreases of \$71,000,000 in bonds and \$2,000,000 in notes.
