## CONDITION OF FEDERAL RESERVE BANKS

The consolidated statement of condition of the Federal reserve banks on December 5, made public by the Federal Reserve Board, shows an increase of \$21,900,000 in holdings of discounted bills and decreases of \$4,600,000 in bills bought in open market and of \$2,500,000 in Government securities. Member bank reserve deposits increased \$21,400,000, Federal reserve note circulation \$24,300,000 and cash reserves \$14,700,000. Total bills and securities were \$14,900,000 above the amount held on November 28.

The principal changes in holdings of discounted bills for the week were increases of \$44,200,000 at the Federal Reserve Bank of Chicago and \$13,200,000 at New York, and decreases of \$9,900,000 at Boston, \$8,300,000 at Richmond, \$5,900,000 at Cleveland, \$5,400,000 at Minneapolis and \$3,000,000 at Kansas City. The System's holdings of bills bought in open market declined \$4,600,000 and of Treasury certificates \$4,700,000, while holdings of Treasury notes increased \$2,200,000.

All Federal reserve banks except New York show increases in Federal reserve note circulation for the week, the principal changes by Federal reserve banks being increases of \$7,200,000 at Boston, \$6,300,000 at Chicago, \$3,800,000 at Atlanta, and \$3,300,000 at San Francisco, and a decrease of \$4,000,000 at New York.
