CONDITION OF FEDERAL RESERVE BANKS

The consolidated statement of condition of the Federal reserve banks on January 2, made public by the Federal Reserve Board, shows decreases for the week of \$16,100,000 in holdings in discounted bills and of \$4,900,000 in bills bought in open market and an increase of \$11,600,000 in holdings of U. S. Government securities. Member bank reserve deposits increased \$84,600,000, Government deposits \$15,200,000 and cash reserves \$29,700,000, while Federal reserve note circulation decreased \$81,500,000. Total bills and securities were \$9,700,000 below the amount held on December 26.

The principal changes in holdings of discounted bills for the week were an increase of \$107,600,000 at the Federal Reserve Bank of New York and decreases of \$36,100,000 at Boston, \$27,900,000 at Chicago, \$20,900,000 at Cleveland, \$12,600,000 at Philadelphia and \$12,000,000 at San Francisco. The System's holdings of bills bought in open market decreased \$4,900,000 and of Treasury certificates \$4,400,000, while holdings of Treasury notes increased \$16,200,000.

Federal reserve note circulation was \$81,500,000 less than a week ago, all of the Federal reserve banks reporting decreases in circulation, the largest declines being \$17,000,000 at Philadelphia, \$15,100,000 at Cleveland, \$10,200,000 each at New York and Chicago, \$7,200,000 at Boston and \$6,300,000 at San Francisco.

Following the December 31 closing of books the Federal reserve banks transferred \$21,079,000 to surplus, increasing that account to \$254,398,000.
