CONDITION OF FEDERAL RESERVE BANKS

The daily average volume of Federal reserve bank credit outstanding during the week ending June 29, as reported by the Federal reserve banks, was \$2,354,000,000, an increase of \$59,000,000 compared with the preceding week and of \$1,400,000,000, compared with the corresponding week in 1931.

On June 29 total reserve bank credit amounted to \$2,346,000,000, an increase of \$58,000,000 for the week. This increase corresponds with an increase of \$144,000,000 in money in circulation, offset in part by decreases of \$32,000,000 in member bank reserve balances, and \$9,000,000 in unexpended capital funds, non-member deposits, etc., and increases of \$41,000,000 in Treasury currency, adjusted, and \$3,000,000 in monetary gold stock.

Holdings of discounted bills increased \$6,000,000 at the Federal Reserve Bank of New York, and decreased \$13,000,000 at San Francisco, \$5,000,000 at Atlanta and \$18,000,000 at all Federal reserve banks. The System's holdings of bills bought in open market increased \$10,000,000, of United States Treasury notes \$43,000,000, of Treasury certificates and bills \$22,000,000, and of United States bonds \$6,000,000.
