CONDITION OF FEDERAL RESERVE BANKS

The daily average volume of Federal Reserve bank credit outstanding during the week ended August 29, as reported by the Federal Reserve banks, was \$2,461,000,000, a decrease of \$3,000,000 compared with the preceding week and an increase of \$194,000,000 compared with the corresponding week in 1933.

On August 29 total Reserve bank credit amounted to \$2,463,000,000, an increase of \$6,000,000 for the week. This increase corresponds with an increase of \$55,000,000 in member bank reserve balances and a decrease of \$2,000,000 in monetary gold stock, offset in part by decreases of \$28,000,000 in Treasury cash and deposits with Federal Reserve banks, \$9,000,000 in nonmember deposits and other Federal Reserve accounts and \$2,000,000 in money in circulation and an increase of \$13,000,000 in Treasury and National bank currency.

The System's holdings of bills and securities remained practically unchanged, an increase of \$9,000,000 in holdings of United States Treasury notes being offset by a decrease in holdings of Treasury certificates and bills.
