Condition of Weekly Reporting Member Banks in 101 Leading Cities

The condition statement of weekly reporting member banks in 101 leading cities on November 25 shows a decrease for the week of \$41,000,000 in total loans and investments, an increase of \$65,000,000 in demand deposits-adjusted, and decreases of \$72,000,000 in Government deposits, \$69,000,000 in deposits credited to domestic banks, \$30,000,000 in balances with domestic banks, and \$40,000,000 in reserve balances with Federal Reserve banks.

Loans to brokers and dealers in New York City increased \$55,000,000, loans to brokers and dealers outside New York increased \$1,000,000, and loans on securities to others (except banks) declined \$10,000,000. Holdings of acceptances and commercial paper bought declined \$8,000,000, real estate loans increased \$4,000,000, and loans to banks increased \$6,000,000. "Other loans" declined \$15,000,000 in the New York district, \$8,000,000 in the Chicago district, and \$21,000,000 at all reporting member banks.

Holdings of United States Government direct obligations declined \$26,000,000 in the New York district, \$13,000,000 in the Boston district, and \$56,000,000 at all reporting member banks. Holdings of obligations fully guaranteed by the United States Government declined \$16,000,000 in the Richmond district, \$8,000,000 in the New York district and \$14,000,000 at all reporting member banks, and increased \$12,000,000 in the Chicago district.

Demand deposits-adjusted increased \$50,000,000 in the New York district and \$65,000,000 at all reporting member banks. Time deposits increased \$11,000,000 in the New York district and \$5,000,000 at all reporting member banks. Government deposits declined \$18,000,000 in the New York district, \$16,000,000 in the Chicago district, \$12,000,000 in the San Francisco district and \$72,000,000 at all reporting member banks. Deposits credited to domestic banks declined \$17,000,000 in the Kansas City district, \$12,000,000 in the Philadelphia district, \$11,000,000 each in the Cleveland and San Francisco districts, and \$69,000,000 at all reporting member banks. Deposits credited to foreign banks increased \$7,000,000 in the New York district.
