Condition of Weekly Reporting Member Banks in Leading Cities

The condition statement of weekly reporting member banks in 101 leading cities shows the following principal changes for the week ended May 13: Increases of \$32,000,000 in holdings of Treasury bills, \$148,000,000 in reserve balances with Federal Reserve Banks, \$121,000,000 in balances with domestic banks, \$387,000,000 in demand deposits-adjusted and \$104,000,000 in deposits credited to domestic banks, and a decrease of \$101,000,000 in United States Government deposits.

Holdings of Treasury bills increased \$44,000,000 in the Chicago District and \$32,000,000 at all reporting member banks. Holdings of United States Government bonds increased \$32,000,000 in New York City and \$40,000,000 at all reporting member banks.

Demand deposits-adjusted increased \$163,000,000 in New York City, \$51,000,000 in the San Francisco District, and \$387,000,000 at all reporting member banks. United States Government deposits declined \$44,000,000 in the Chicago District, \$34,000,000 in New York City and \$101,000,000 at all reporting member banks.

Deposits credited to domestic banks increased \$41,000,000 in New York City and \$104,000,000 at all reporting member banks.
