H.4.2 CONDITION OF WEEKLY REPORTING MEMBER BANKS IN LEADING CITIES

The condition statement of weekly reporting member banks in leading cities shows the following principal changes for the week ended November 29: Decreases of \$710 million in U. S. Government demand deposits and \$743 million in borrowings, and an increase of \$1,262 million in demand deposits adjusted.

Commercial and industrial loans increased in nine districts and a net of \$87 million; the increase during the comparable week a year ago was \$55 million. Loans to brokers and dealers for purchasing or carrying U. S. Government securities decreased \$313 million, but their loans for purchasing and carrying "other" securities increased \$47 million. Loans to nonbank financial institutions increased \$44 million, compared with an increase of \$35 million in the similar week of 1960. Other loans increased \$41 million.

Holdings of Treasury bills by weekly reporting member banks increased \$78 million, and holdings of "other" securities increased \$70 million.

Demand deposits adjusted increased \$656 million in New York City, \$275 million in the Chicago District, \$102 million in the Cleveland District, \$90 million in the San Francisco District, and \$79 million in the Dallas District. Time and savings deposits increased a net of \$20 million; this largely reflected an increase of \$49 million in "other" time deposits of individuals, partnerships, and corporations in New York City, and a decrease of \$29 million in savings deposits in the Kansas City District.
