H.4.2 CONDITION OF WEEKLY REPORTING MEMBER BANKS IN LEADING CITIES

The condition statement of weekly reporting member banks in leading cities shows the following principal changes for the week ended June 12: Increases of \$298 million in loans adjusted and \$1,333 million in demand deposits adjusted, and a decrease of \$1,045 million in U. S. Government demand deposits.

Commercial and industrial loans increased in ten districts and a net of \$68 million; during the comparable week a year ago these loans increased \$103 million. Loans to brokers and dealers for purchasing or carrying U. S. Government securities increased \$53 million, and their loans for purchasing or carrying "other" securities increased \$31 million. Loans to sales and personal financing institutions decreased \$35 million and loans to "other" nonbank financial institutions increased \$65 million, as compared with a decrease of \$6 million and an increase of \$51 million, respectively, during the similar week in 1962. Real estate loans increased \$79 million. "Other" loans increased \$29 million.

Holdings of Treasury bills by weekly reporting member banks decreased \$53 million, Treasury certificates decreased \$4 million, and the combined total of Treasury notes and U. S. Government bonds decreased \$37 million. "Other" securities increased \$112 million.

Demand deposits adjusted increased in all districts, and included increases of \$656 million in New York City, \$197 million in the San Francisco District, \$150 million in the Cleveland District, and \$119 million in the Chicago District. Savings deposits increased \$55 million and "other" time deposits of individuals, partnerships, and corporations increased \$115 million.

Borrowings of weekly reporting member banks from Federal Reserve Banks increased \$47 million but borrowings from others decreased \$168 million. Loans to domestic commercial banks decreased \$75 million.
