CONDITION OF WEEKLY REPORTING MEMBER BANKS IN LEADING CITIES

The condition statement of weekly reporting member banks in leading cities shows the following principal changes for the week ended April 6: increases of \$84 million in loans adjusted, \$214 million in holdings of U. S. Government securities, \$703 million in reserves with Federal Reserve Banks, \$281 million in demand deposits adjusted, a decrease of \$1,238 million in U. S. Government demand deposit, and an increase of \$1,463 million in demand deposits credited to domestic commercial banks.

Commercial and industrial loans decreased a net of \$209 million; during the comparable week a year ago these loans decreased \$257 million. Loans to brokers and dealers for purchasing or carrying U. S. Government securities increased \$138 million, and their loans for purchasing or carrying "other" securities increased \$241 million. Loans to sales and personal financing institutions decreased \$89 million and loans to "other" nonbank financial institutions increased \$11 million, as compared with decreases of \$284 million and \$31 million, respectively, during the similar week in 1965. Real estate loans decreased \$17 million. "Other" loans increased \$10 million.

Holdings of Treasury bills by weekly reporting member banks increased \$228 million, Treasury certificates increased \$8 million, and the combined total of Treasury notes and U. S. Government bonds decreased \$22 million. "Other" securities increased \$43 million.

Demand deposits adjusted increased \$356 million in the San Francisco District, \$175 million in New York City, \$111 million in the Boston District, and \$93 million in the Richmond District, and decreased \$169 million in the New York District outside New York City, and \$147 million in the Dallas District. Savings deposits decreased \$574 million and "other" time deposits of individuals, partnerships, and corporations increased \$755 million.

Borrowings of weekly reporting member banks from Federal Reserve Banks increased \$211 million but borrowings from others decreased \$141 million. Loans to domestic commercial banks decreased \$427 million.
