H.4.2 CONDITION OF WEEKLY REPORTING MEMBER BANKS IN LEADING CITIES

The condition statement of weekly reporting member banks in leading cities shows the following principal changes for the week ended May 11: decreases of \$327 million in loans adjusted, \$9 million in holdings of U. S. Government securities, \$1,439 million in reserves with Federal Reserve Banks, \$702 million in demand deposits adjusted, \$373 million in U. S. Government demand deposits, and \$302 million in demand deposits credited to domestic commercial banks.

*able week a year ago these loans increased \$185 million. Loans to brokers and dealers for purchasing or carrying U. S. Government securities decreased \$6 million, and their loans for purchasing or carrying "other" securities decreased \$26 million. Loans to sales and personal financing institutions decreased \$374 million and loans to "other" nonbank financial institutions decreased \$46 million, as compared with a decrease of \$211 million and an increase of \$29 million, respectively, during the similar week in 1965. Real estate loans increased \$83 million. "Other" loans decreased \$28 million.

Holdings of Treasury bills by weekly reporting member banks increased \$46 million,
Treasury certificates decreased \$1 million, and the combined total of Treasury notes and
U. S. Government bonds decreased \$54 million. "Other" securities decreased \$34 million.

Demand deposits adjusted decreased in nine districts including decreases of \$284 million in New York City, \$116 million in the Chicago District, \$99 million in the New York District outside New York City, and \$98 million in the Boston District. Savings deposits decreased \$37 million and "other" time deposits of individuals, partnerships, and corporations increased \$235 million.

Borrowings of weekly reporting member banks from Federal Reserve Banks decreased \$670 million but borrowings from others increased \$312 million. Loans to domestic scommercial banks increased \$291 million.
