WEEKLY CONDITION REPORT OF LARGE COMMERCIAL BANKS AND DOMESTIC SUBSIDIARIES

Total loans and investments (adjusted) at large commercial banks decreased \$385 million in the week ended July 30. This reflected a decrease of \$3 million in loans (adjusted), a decrease of \$368 million in U. S. Treasury security holdings and a decrease of \$14 million in holdings of "other" securities. Demand deposits adjusted increased \$481 million while U. S. Government demand deposits decreased \$1,852 million. Total time and savings deposits decreased \$463 million. Gross liabilities of banks to their foreign branches increased \$110 million.

Commercial and industrial loans decreased a net of \$403 million; during the comparable week a year ago these loans increased \$61 million. Loans to brokers and dealers for purchasing or carrying U. S. Treasury securities increased \$139 million, and their loans for purchasing or carrying "other" securities increased \$14 million. Sales of Federal funds and purchase of securities under agreements to resell with brokers and dealers involving U. S. Treasury securities increased \$425 million and those involving "other" securities decreased \$4 million. Loans to sales and personal finance institutions decreased \$157 million as compared with an increase of \$164 million during the corresponding week in 1968. Real estate loans increased \$34 million, and consumer instalment loans increased \$83 million.

Total U. S. Treasury securities held decreased \$368 million. Holdings of Treasury bills decreased \$320 million and holdings of "other" U. S. Treasury securities maturing within 1 year increased \$29 million. Longer term Treasury note and bond holdings decreased \$77 million.

Savings deposits declined \$153 million and "other" time deposits declined \$310 million. Negotiable CD's issued in denominations of \$100,000 or more, included in the latter figure, declined \$233 million.
