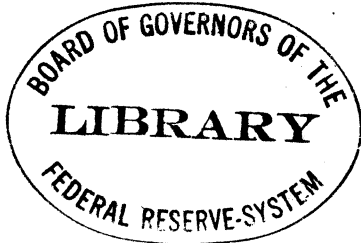

WEEKLY CONDITION REPORT OF LARGE COMMERCIAL BANKS AND DOMESTIC SUBSIDIARIES

Total loans and investments (adjusted) at large commercial banks decreased \$157 million in the week ended July 28. This reflected a decrease of \$115 million in loans (adjusted), a decrease of \$439 million in U.S. Treasury security holdings and an increase of \$397 million in holdings of "other" securities. Demand deposits adjusted increased \$605 million while U.S. Government demand deposits decreased \$881 million. Total time and savings deposits increased \$527 million. Gross liabilities of banks to their foreign branches decreased \$382 million.

Commercial and industrial loans decreased a net of \$358 million; during the comparable week a year ago these loans decreased \$593 million. Loans to brokers and dealers for purchasing or carrying U. S. Treasury securities increased \$120 million, and their loans for purchasing or carrying "other" securities decreased \$71 million. Sales of Federal funds and purchase of securities under agreements to resell with brokers and dealers involving U.S. Treasury securities increased \$233 million and those involving "other" securities increased \$27 million. Loans to sales and personal finance institutions decreased \$164 million as compared with a decrease of \$301 million during the corresponding week in 1970. Real estate loans increased \$57 million, and consumer instalment loans increased \$32 million.

Total U.S. Treasury securities held decreased \$349 million. Holdings of Treasury bills decreased \$381 million and holdings of "other" U.S. Treasury securities maturing within 1 year increased \$10 million. Longer term Treasury note and bond holdings decreased \$68 million.

Savings deposits declined \$145 million and "all other" time deposits increased \$382 million. Negotiable CD's issued in denominations of \$100, 000 or more included in the latter figure, increased \$451 million.
