WEEKLY CONDITION REPORT OF LARGE COMMERCIAL BANKS AND DOMESTIC SUBSIDIARIES

Total loans and investments (adjusted) at large commercial banks decreased \$1,127 million in the week ended February 9. This reflected a decrease of \$594 million in loans (adjusted), a decrease of \$395 million in U.S. Treasury security holdings and a decrease of \$138 million in holdings of "other" securities. Demand deposits adjusted decreased \$2,322 million while U.S. Government demand deposits increased \$232 million. Total time and savings deposits increased \$409 million. Gross liabilities of banks to their foreign branches decreased \$238 million.

Commercial and industrial loans increased a net of \$47 million; during the comparable week a year ago these loans increased \$57 million. Loans to brokers and dealers for purchasing or carrying U.S. Treasury securities decreased \$142 million, and their loans for purchasing or carrying "other" securities decreased \$185 million. Sales of Federal funds and purchase of securities under agreements to resell with brokers and dealers involving U.S. Treasury securities decreased \$208 million and those involving "other" securities decreased \$20 million. Loans to sales and personal finance institutions increased \$84 million as compared with a decrease of \$358 million during the corresponding week in 1971. Real estate loans increased \$66 million, and consumer instalment loans decreased \$60 million.

Total U.S. Treasury securities held decreased \$395 million. Holdings of Treasury bills decreased \$447 million and holdings of "other" U.S. Treasury securities maturing within 1 year increased \$21 million. Longer term Treasury note and bond holdings increased \$31 million.

Savings deposits increased \$164 million and "all other" time deposits increased \$245 million. Negotiable CD 's issued in denominations of \$100,000 or more, included in the latter figure, increased \$105 million.
