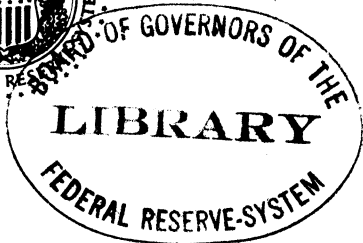

WEEKLY CONDITION REPORT OF LARGE COMMERCIAL BANKS AND DOMESTIC SUBSIDIARIES

Total loans and investments (adjusted) at large commercial banks increased \$2,743 million in the week ended March 15. This reflected an increase of \$2,727 million in loans (adjusted), a decrease of \$442 million in U.S. Treasury security holdings and an increase of \$458 million in holdings of "other" securities. Demand deposits adjusted increased \$5,212 million while U.S. Government demand deposits increased \$2,110 million. Total time and savings deposits decreased \$1,052 million. Gross liabilities of banks to their foreign branches increased \$95 million.

Commercial and industrial loans increased a net of \$797 million; during the comparable week a year ago these loans increased \$606 million. Loans to brokers and dealers for purchasing or carrying U.S. Treasury securities increased \$218 million, and their loans for purchasing or carrying "other" securities increased \$389 million. Sales of Federal funds and purchase of securities under agreements to resell with brokers and dealers involving U.S. Treasury securities increased \$31 million and those involving "other" securities increased \$60 million. Loans to sales and personal finance institutions increased \$434 million as compared with an increase of \$158 million during the corresponding week in 1971. Real estate loans increased \$148 million, and consumer instalment loans increased \$14 million.

Total U.S. Treasury securities held decreased \$442 million. Holdings of Treasury bills decreased \$319 million and holdings of "other" U.S. Treasury securities maturing within 1 year decreased \$14 million. Longer term Treasury note and bond holdings decreased \$109 million.

Savings deposits increased \$215 million and "all other" time deposits declined \$837 million. Negotiable CD's issued in denominations of \$100,000 or more, included in the latter figure, declined \$1,160 million.
