WEEKLY CONDITION REPORT OF LARGE COMMERCIAL BANKS AND DOMESTIC SUBSIDIARIES

Total loans and investments (adjusted) at large commercial banks increased \$1,060 million in the week ended April 12. This reflected an increase of \$524 million in loans (adjusted), a decrease of \$167 million in U.S. Treasury security holdings and an increase of \$703 million in holdings of "other" securities. Demand deposits adjusted increased \$1,246 million while U.S. Government demand deposits decreased \$2,129 million. Total time and savings deposits increased \$716 million. Gross liabilities of banks to their foreign branches decreased \$79 million.

Commercial and industrial loans increased a net of \$151 million; duirng the comparable week a year ago these loans increased \$125 million. Loans to brokers and dealers for purchasing or carrying U.S. Treasury securities decreased \$32 million, and their loans for purchasing or carrying "other" securities decreased \$258 million. Sales of Federal funds and purhcase of securities under agreements to resell with brokers and dealers involving U.S. Treasury securities increased \$398 million and those involving "other" securities decreased \$45 million. Loans to sales and personal finance institutions increased \$56 million as compared with an increase of \$49 million during the corresponding week in 1971. Real estate loans increased \$162 million, and consumer instalment loans increased \$52 million.

Total U.S. Treasury securities held decreased \$167 million. Holdings of Treasury bills decreased \$91 million and holdings of "other" U.S. Treasury securities maturing within 1 year decreased \$59 million. Longer term note and bond holdings decreased \$17 million.

Savings deposits declined \$177 million and "all other" time deposits increased \$539 million. Negotiable CD's issued in denominations of \$100,000 or more, included in the latter figure, increased \$533 million. **ب** مر
