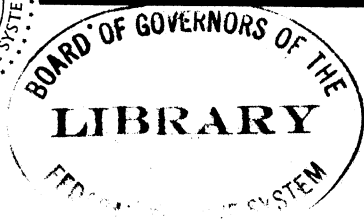

WEEKLY CONDITION REPORT OF LARGE COMMERCIAL BANKS AND DOMESTIC SUBSIDIARIES

Total loans and investments (adjusted) at large commercial banks increased \$1,161 million in the week ended April 19. This reflected an increase of \$1,778 million in loans (adjusted), a decrease of \$366 million in U.S. Treasury security holdings and a decrease of \$251 million in holdings of "other" securities. Demand deposits adjusted decreased \$1,062 million while U.S. Government demand deposits increased \$3,649 million. Total time and savings deposits increased \$832 million. Gross liabilities of banks to their foreign branches increased \$220 million.

Commercial and industrial loans increased a net of \$651 million; during the comparable week a year ago these loans increased \$154 million. Loans to brokers and dealers for purchasing or carrying U.S. Treasury securities increased \$49 million, and their loans for purchasing or carrying "other" securities increased \$381 million. Sales of Federal funds and purchase of securities under agreements to resell with brokers and dealers involving U.S. Treasury securities increased \$44 million and those involving "other" securities increased \$40 million. Loans to sales and personal finance institutions showed no change as compared with an increase of \$125 million during the corresponding week in 1971. Real estate loans increased \$196 million, and consumer instalment loans increased \$105 million.

Total U.S. Treasury securities held decreased \$366 million. Holdings of Treasury bills decreased \$215 million and holdings of "other" U.S. Treasury securities maturing within 1 year decreased \$39 million. Longer term Treasury note and bond holdings decreased \$112 million.

Savings deposits declined \$316 million and "all other" time deposits increased \$516 million. Negotiable CD's issued in denominations of \$100,000 or more, included in the latter figure, increased \$561 million.
