WEEKLY CONDITION REPORT OF LARGE COMMERCIAL BANKS AND DOMESTIC SUBSIDIARIES

Total loans and investments (adjusted) at large commercial banks increased \$3,106 million in the week ended December 27. This reflected an increase of \$2,651 million in loans (adjusted), an increase of \$467 million in U.S. Treasury security holdings and a decrease of \$12 million in holdings of "other" securities. Demand deposits adjusted increased \$1,833 million while U.S. Government demand deposits decreased \$1,001 million. Total time and savings deposits increased \$650 million. Gross liabilities of banks to their foreign branches decreased \$401 million.

Commercial and industrial loans increased a net of \$241 million; during the comparable week a year ago these loans increased \$96 million. Loans to brokers and dealers for purchasing or carrying U.S. Treasury securities increased \$470 million, and their loans for purchasing or carrying "other" securities decreased \$159 million. Sales of Federal funds and purchase of securities under agreements to resell with brokers and dealers involving U.S. Treasury securities increased \$718 million and those involving "other" securities increased \$90 million. Loans to sales and personal finance institutions increased \$138 million as compared with an increase of \$238 million during the corresponding week in 1971. Real estate loans increased \$43 million, and consumer instalment loans increased \$112 million.

Total U.S. Treasury securities held increased \$467 million. Holdings of Treasury bills increased \$506 million and holdings of "other" U.S. Treasury securities maturing within 1 year increased \$13 million. Longer term Treasury note and bond holdings decreased \$52 million.

Savings deposits increased \$63 million and "all other" time deposits increased \$597 million. Negotiable CD's issued in denominations of \$100,000 or more, included in the latter figure, increased \$461 million. F
