WEEKLY CONDITION REPORT OF LARGE COMMERCIAL BANKS AND DOMESTIC SUBSIDIARIES

Total loans and investments (adjusted) at large commercial banks increased \$2,147 million in the week ended April 17. This reflected an increase of \$2,865 million in loans (adjusted), a decrease of \$901 million in U.S. Treasury security holdings and an increase of \$183 million in holdings of "other" securities. Demand deposits adjusted increased \$78 million while U.S. Government demand deposits increased \$3,070 million. Total time and savings deposits increased \$793 million. Gross liabilities of banks to their foreign branches increased \$89 million.

Commercial and industrial loans increased a net of \$1,506 million; during the comparable week a year ago these loans increased \$1,115 million. Loans to brokers and dealers for purchasing or carrying U.S. Treasury securities decreased \$87 million, and their loans for purchasing or carrying "other" securities increased \$45 million. Sales of Federal funds and purchase of securities under agreements to resell with brokers and dealers involving U.S. Treasury securities decreased \$38 million and those involving "other" securities increased \$54 million. Loans to sales and personal finance institutions increased \$423 million as compared with an increase of \$101 million during the corresponding week in 1973. Real estate loans increased \$220 million, and consumer instalment loans increased \$79 million.

Total U.S. Treasury securities held decreased \$901 million. Holdings of Treasury bills decreased \$755 million and holdings of "other" U.S. Treasury securities maturing within 1 year decreased \$78 million. Longer term Treasury note and bond holdings decreased \$68 million.

Savings deposits declined by \$359 million (the previous week's figure was revised to a \$90 million decrease). All other consumer-type time deposits (i.e. other time IPC less large negotiable CD's IPC) increased by \$32 million (the previous week's figure was revised to a \$59 million decrease)
