4. For U.S. branches and agencies of foreign banks includes lease financing receivables.

6. Includes net due from related institutions abroad for U.S. branches and agencies of foreign banks having a net due from position.
7. For U.S. branches and agencies of foreign banks includes other transaction deposits.
8. Includes NOW, ATS, and telephone and pre-authorized transfer savings deposits.

NOTE 1: District data for January 9, 1991 contained errors. The affected districts were: New York (including New York City), Atlanta, Chicago, Minneapolis, Kansas City, and Dallas. Corrected data are available from the Banking and Money Market Statistics Section, Stop 84, Board of Governors of the Federal Reserve System, Washington, DC 20551.

NOTE 2: Weekly reporting banks acquired \$2.3 billion in assets and liabilities of thrift institutions in the week ending January 16, 1991. The major asset item affected was cash and balances due from depository institutions, \$2.3 billion. The major liability items affected were other transaction deposits, \$0.2 billion and nontransaction balances-IPC, \$2.1 billion. In the week ending January 2, 1991 weekly reporting banks acquired \$1.0 billion in assets and liabilities of thrift institutions. The major asset items affected were (in billions) loans to individuals, \$0.6 and real estate loans, all other, \$0.3. The major liability item affected was nontransaction deposits-IPC, \$0.2. Effective January 2, 1991 reclassifications increased real estate loans, all other \$400 million. Commercial and industrial loans to U.S. addressees were reduced \$300 million and other trading account assets were reduced \$100 million. In the week ending October 3, 1990 reclassifications reduced U.S. treasury securities investment account maturing in over one to five years \$100 million and increased other securities investment account other bonds, stocks and securities the same amount. A reclassification the week ending September 26, 1990 increased U.S. treasury securities investment account maturing in over one to five years \$100 million and reduced U.S. treasury securities investment account mortgage-backed securities the same amount. Effective August 8, 1990 a reclassification increased real estate loans, all other \$100 million and reduced commercial and industrial loans to U.S. addressees the same amount. A reclassification the week ending August 1, 1990 reduced real estate loans, all other \$100 million and increased all other loans the same amount.
