- Includes net due from related institutions abroad for U.S. branches and agencies of foreign banks having a net due from position.
- For U.S. branches and agencies of foreign banks includes other transaction deposits.
- Includes NOW, ATS, and telephone and pre-authorized transfer savings deposits.

NOTE: Weekly reporting banks acquired \$600 million in assets and liabilities of thrift institutions in the week ending July 3, 1991. The major asset item affected (in millions) was: real estate loans, all other \$300. The major liability items affected were: nontransaction deposits-IPC, \$500 and other transaction deposits, \$100. In the week ending July 10, 1991, weekly reporting banks acquired \$500 million in assets and liabilities of thrift institutions. The major asset item affected was (in millions): other assets, \$500. The major liability item affected was nontransaction deposits-IPC, \$500. At domestically chartered banks, a reclassification reduced U.S. government securities investment account mortgage-backed securities \$200 million and increased other securities investment account other bonds, stocks, and securities the same amount.
