NOTE: Domestically chartered weekly reporting banks acquired \$2.3 billion in assets and liabilities of thrift institutions in the week ending April 1, 1992. The major asset items affected were (in billions): cash and balances due from depository institutions, \$0.6; U.S. government securities, investment account, maturing in one to five years, \$0.1; real estate loans, all other, \$0.1; and other assets, \$1.5. The major liability items affected were: other transactions deposits, \$0.1; and nontransaction deposits-IPC, \$2.2 billion. The major memoranda item affected was: time deposits in amounts of \$100,000 or more, \$0.1. At domestically chartered banks a reclassification in the week ending April 1, 1992, reduced U.S. government securities, investment account, mortgage-backed securities \$0.3 and increased U.S. government securities, investment account, maturing in over five years the same amount. At U.S. branches and agencies of foreign banks a reclassification in the week ending April 1, 1992, reduced commercial and industrial loans to U.S. addressees \$0.1 and increased loans to nonbank financial institutions the same amount.
