1. Includes certificates of participation, issued or guaranteed by agencies of the U.S. government, in pools of residential mortgages.

3. For U.S. branches and agencies of foreign banks includes transactions with nonbank brokers and dealers in securities.
4. For U.S. branches and agencies of foreign banks includes lease financing receivables.
5. Includes allocated transfer risk reserve.
6. Includes net due from related institutions abroad for U.S. branches and agencies of foreign banks having a net due from position.
7. For U.S. branches and agencies of foreign banks includes other transaction deposits.
8. Includes NOW, ATS, and telephone and pre-authorized transfer savings deposits.
9. Includes borrowings only from other than directly related institutions.
10. Includes securities sold under agreements to repurchase.
11. For domestically chartered banks includes federal funds purchased and securities sold under agreements to repurchase.

18. Trading account securities and other trading account assets are not available on a district basis. They are included in other assets.

NOTE: Weekly reporting domestic banks acquired \$2.9 billion in assets and liabilities of thrift institutions in the week ending November 2, 1994. The major asset items affected were (in billions): U.S. government securities investment account mortgage-backed securities, \$0.2; U.S. government securities investment account maturing in over 1 to 5 years, \$0.2; U.S. government securities investment account maturing in over 5 years, \$0.1; real estate loans, all other, \$2.2; and other assets, \$0.1. The major liability items affected were: other transaction deposits, \$0.2; nontransaction deposits-IPC, \$2.2; nontransaction deposits-state and political subdivisions, \$0.1; borrowings, \$0.1; and the residual, \$0.2. The major memoranda item affected was: time deposits in amounts of \$100,000 or more, \$0.6.
