6. Includes net due from related institutions abroad for U.S. branches and agencies of foreign banks having a net due from position.
7. For U.S. branches and agencies of foreign banks includes other transaction deposits.

NOTE: Reclassifications at U.S. branches and agencies of foreign banks increased federal funds sold to others \$700 million and reduced loans to foreign governments and official institutions \$400 million and loans for purchasing and carrying securities \$300 million the week ending October 25, 1995. In addition, borrowings, federal funds purchased from others increased \$1100 million and borrowings, other liabilities for borrowed money to others decreased the same amount.
