For MSBs the interest rate ceiling is one-quarter per cent higher. This new category of deposits was authorized beginning on June 1, 1978.

<sup>3/</sup> Estimates for all mutual savings banks in April are based on data collected by the FDIC from a stratified random sample of about 105 banks.

<sup>4/</sup> For April 25, the standard error associated with the dollar estimates for commercial banks is about \$1 billion, and for mutual savings banks the standard error is about \$445 million. For March 28, the standard errors for commercial banks and mutual savings banks are \$845 and \$500 million, respectively.
