Money market certificates are nonnegotiable time deposits in denominations of \$10,000 or more with original maturities of exactly 26 weeks for which the maximum permissible rate of interest on new deposits at commercial banks is equal to the discount yield on the most recently issued six-month Treasury bill (auction average). For MSBs the interest rate ceiling is one-quarter percent higher. This new category of deposits was authorized beginning on June 1, 1978.

Estimates for all insured commercial banks in August are based on data collected by the Federal Reserve and the FDIC from a stratified random sample of about 525 banks.

^{3/} Estimates for all mutual savings banks in July are based on data collected by the FDIC from a stratified random sample of about 100 banks.

^{4/} For August 19, the standard error associated with the dollar estimates for commercial banks is about \$1.3 billion, and for mutual savings banks the standard error is about \$530 million. For July 25, the standard errors for commercial banks and mutual savings banks are \$1.2 billion and \$600 million, respectively.
