## DEMAND DEPOSITS, CURRENCY, AND RELATED ITEMS

Seasonally adjusted money supply (as defined to consist of demand deposits adjusted and currency outside banks), is estimated at \$144.9 billion in the first half of January, \$600 million lower than in the last half of December, but maintained the same level as the December monthly average. In the same period, gross time deposits of commercial banks increased \$1.0 billion.
