## DEMAND DEPOSITS, CURRENCY, AND RELATED ITEMS

Seasonally adjusted money supply is estimated at \$160.2 billion in the first half of January, \$800 million higher than the average for the month of December. Time deposits adjusted averaged \$1.5 billion higher in the first half of January than in the month of December.

NOTE--Money supply consists of (1) demand deposits at all commercial banks, other than those due to domestic commercial banks and the U. S. Government, less cash items in process of collection and Federal Reserve float; (2) foreign demand balances at Federal Reserve Banks; and (3) currency outside the Treasury, the Federal Reserve and the vaults of all commercial banks.

Time deposits adjusted are time deposits at all commercial banks other than those due to domestic commercial banks and the U. S. Government.
