- The large increases in the week ending February 15, 1947 reflect in part the fact that last year sales in the City of New York were reduced because of the closing of all business establishments on February 12 to avoid a fuel shortage, those in the City of Philadelphia were reduced because of a curtailment in public transportation service on February 11 and 12, and those in Pittsburgh were reduced because stores closed on February 12 owing to a power shortage.
- Sales in the week ending February 22, 1947 were sharply reduced because of heavy snow storms along the Atlantic Coast.
- Sales in Milwaukee during the week ending February 1, 1947 were reduced because of snow storm.
