1/ During March and April changes from a year ago reflect in part the fact that last year Easter was on April 21, while this year it was on April 6. For this reason it is estimated that in comparison with last year allowance should be made for an increase in sales of about 3 per cent for the month of March as a whole and for a corresponding decrease for the month of April as a whole.

Sales in these weeks were reduced owing to a curtailment in public transportation service.
