- 1/ During March and April changes from a year ago reflect in part the fact that last year Easter was on April 9 while this year it was on March 25. For this reason it is estimated that in comparison with last year allowance should be made for an increase in sales of about 4 per cent for the month of March as a whole and for a corresponding decrease for the month of April as a whole.
