Mergers, Consolidation, and Establishment of Branches

- 2 Central Trust Company Rochester, N.Y., Rochester, 12-10-62
New York, and Prattsburgh State Bank, Prattsburgh,
New York, both State members, merged under charter
and title of Central Trust Company Rochester, N.Y.
A branch was established in the former location of
Prattsburgh State Bank.
- 3 Littlestown State Bank and Trust Company, Littlestown, 12-10-62
Pennsylvania, a State member, and First National Bank
of Gettysburg, Gettysburg, Pennsylvania, merged under
the charter of the latter and title of Adams County
National Bank, with head office transferred to the

be operated as branches by the continuing bank.
